**CHARGE**

I, **CHANDRAKANTH**, Addl. Civil Judge & JMFC Aland, do hereby charge you,

**ACCUSED:**

1. Chandrakanth S/o Guranna Biredar,  
Aged: 65 years, Occ: Agriculture,  
R/o. Basavan Sangolagi Village.
2. Kamalabai W/o Chandrakanth Biredar,  
Aged: 60 years, Occ: Household,  
R/o. Basavan Sangolagi Village.
3. Ashok S/o Chandrakanth Biradar,  
Aged: 32 years, Occ: Agriculture  
R/o. Basavan Sangolagi Village.
4. Basavaraj S/o Chandrakanth Biradar,  
Aged: 30 years, Occ: Agriculture,  
R/o. Basavan Sangolagi Village.

As follows;

Firstly, that on 28.06.2018 at 12:30 p.m., at Basavan Sangolagi Village, in Aland Taluk, within the limits of Naronna Police Station, when C.Ws.1, 4 and 5 asked you, the accused No.1 not to fix the door attaching to their wall, at that time, you, the accused No.1 intentionally insulted C.W.4 by abusing him in filthy language stating that "ಏ ಬೊಸಡಿ ಮಗನೆ ನಿನ್ನಾವನೊಲೆ ಕೇಳೊದು " and thus insulted CW.4

intending or knowing it to be likely that such provocation will cause him to break the public peace or to commit any other offence and thereby committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Secondly, that on the above said date, time and place, in furtherance of above offence and in furtherance of common intention, when CW1 asked you to not to abused him, you, the accused No.2 assaulted to CW1 with fist on the left side of CW1 and caused internal injury, when CW5 tried to pacify the quarrel, you, the accused No.3 and 4 knocked CW1 and thereby committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Finally, that on the above said date, time and place, in furtherance of the above offence and in furtherance of common intention, when C.W.5 tried to pacify the quarrel, you, the accused No.3 and 4 assaulted CW5 with stone on his back and caused simple injury and thereby committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within my cognizance of this Court.

And I hereby direct that you be tried by this court on the said charge.
