C H A R G E

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Shivanand S/o. Tukaram Ginakikar,
Aged: 36 years, Occ: Coolie,
2. Tippanna S/o. Annappa Gijakikar,
Aged: 30 years, Occ: Coolie,
Above both are R/o. Honnalli village, Tq: Aland.
3. Shivalingappa S/o. Guranna Birejdar,
Aged: 35 years, Occ: Agriculture,
R/o. Basagi village, Tq: Aland.

As follows;

Firstly, that on 26.12.2017 at 11:00 a.m. in front of the court at Aland, within the limits of Aland Police Station, when CW1 was proceeding from the above said place on his personal work, you accused No.1 to 3 in furtherance of your common intention, you accused No.1 and 2 intentionally insulted CW1 by abusing him in filthy language as “ಭೊಸಡಿ ಮಗನೆ ಒಂದು ತಿಂಗಳಾಯ್ತು ಇನ್ನು ನೀನು ಕಬ್ಬು ಕಡಿಯಲಿಕ್ಕೆ ಬಂದಿಲ್ಲಾ ರೊಕ್ಕಾ ಹ್ಯಾಂಗ್ ಕೊಡುತ್ತಿ” and thereby gave provocation to CW1 intending or knowing it likely that such provocation will cause CW1 to break the public peace or to commit any other offence and

thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 3 in furtherance of your common intention, you accused No.1 and 2 have wrongfully confined CW1 and taken him on a motor cycle vehicle bearing registration No.KA-32-2868 to Ibrahimpur Kabbini Toli of Akkalkot Taluka, Maharashtra State by kidnapping the CW1 and thereby you have committed an offence punishable U/Sec.363 Read With Section 34 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 3 in furtherance of your common intention, you accused No.1 voluntarily caused hurt to CW1 with hand and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Fourthly, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 voluntarily assaulted CW1 on his leg with stick and caused grievous injury, if which is used as a weapon of offence is likely to be caused death and thereby you have committed an offence punishable U/Sec.326 R/w Sec.34 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 and 2 criminally intimidated CW1 by threatening to take away

his life, so as to cause alarm in his mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
