C H A R G E

I, YALLAPPA KALLAPUR, Prl. Civil Judge & JMFC Aland, do hereby charge you,

ACCUSED:

1. Mahadevi W/o. Mallikarjun Dhule,
Aged: 60 years, Occ: Housewife,
2. Ganapati S/o. Mallinath Deshatti,
Aged: 30 years, Occ: Agriculture,
3. Mallamma W/o. Mallinath Deshatti,
Aged: 50 years, Occ: Housewife,
Above all are R/o. Devantagi village, Tq: Aland.
4. Kalyani S/o. Walku Pawar,
Aged: 30 years, Occ: Coolie,
5. Shalu S/o. Walku Pawar, (ABATED)
Aged: 25 years, Occ: Coolie,
6. Dadu S/o. Sajanu Kale, (ABATED)
Aged: 22 years, Occ: Coolie,
7. Dadu S/o. Jagir Kale,
Aged: 23 years, Occ: Coolie,
8. Seenu @ Seenay S/o. Dadu,
Aged: 19 years, Occ: Coolie,
9. Lagmu S/o. Jeenu Kale,
Aged: 19 years, Occ: Coolie,

Above all are R/o. Zalaki (K) village, Aland.

As follows;

Firstly, that on 17.10.2015 at 11:30 a.m. at Devantagi village in land bearing Sy.No.63, within the limits of Nimbarga Police Station, you accused Nos.1 to 4 and 7 to 9 alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale, formed an unlawful assembly and in prosecution of common object of the said assembly, namely, to commit rioting, to cause hurt, to intentionally insult and to criminally intimidated and thereby you alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale have committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused you accused Nos.1 to 4 and 7 to 9 alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale, being members of an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence and thereby you alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale have committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused Nos.1 to 4 and 7 to 9 alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale, being members of an unlawful assembly, in prosecution of common object, you accused No.1 intentionally insulted CW1 by abusing him in filthy language as “ಎರಂಡಿ ಮಗನೆ ಹೊಲದ ವ್ಯವಹಾರ ಮುಗಿದು ಹೋಗ್ತಾದ ಮತ್ಯಾಕೆ ಬಂದಿದಿ”, you accused No.2 intentionally insulted CW1 by abusing him in filthy language as “ಈ ಹಾಟ್ಯಾಗೊಳಿಗೆ ಬಿಡಬೇಡರಿ” and thereby gave provocation to him and also intentionally insulted intending or knowing it to be likely that such

provocation will cause him to break the public peace or to commit any other offence and thereby you alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale have committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code, within my cognizance.

Fourthly, that on the above said date, time and place, you accused Nos.1 to 4 and 7 to 9 alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale, being members of an unlawful assembly, in prosecution of common object, you accused No.7 and Shalu, Dadu have wrongfully restrained the movement of CW1 from proceeding further with an intention to commit certain offenses and thereby you alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale have committed an offence punishable U/Sec.341 R/w Sec.149 of Indian Penal Code and within my cognizance.

Fifthly, that on the above said date, time and place, you accused Nos.1 to 4 and 7 to 9 alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale, being members of an unlawful assembly, in prosecution of common object, you accused No.2 voluntarily caused hurt to CW1 on his back with hand, when CW4 came to pacify quarrel, you accused No.2 voluntarily caused hurt to CW4 on her back with hand, you accused Nos.8 and 9 voluntarily caused hurt to CW1 on his back and cheek with hand and thereby you alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code and within my cognizance.

Sixthly, that on the above said date, time and place, you accused Nos.1 to 4 and 7 to 9 alongwith Shalu S/o. Walku Pawar

and Dadu S/o. Sajanu Kale, being members of an unlawful assembly, in prosecution of common object, when CW4 came to pacify the quarrel, you accused Nos.2 pulled the saree of CW4 and used criminal force to CW4 with an intention to outrage her modesty and thereby you alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale have committed an offence punishable U/Sec.354 R/w Sec.149 of Indian Penal Code and within my cognizance.

Finally, that on the above said date, time and place, you accused Nos.1 to 4 and 7 to 9 alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale, being members of an unlawful assembly, in prosecution of common object, have criminally intimidated CW1, 4, 7 by threatening them their lives as “ನಿಮಗೆ ಇನ್ನು ಮುಂದೆ ನೋಡಕೊತೇವು” so as to cause alarm in their mind and thereby you alongwith Shalu S/o. Walku Pawar and Dadu S/o. Sajanu Kale have committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
