The State through Nimbarga P.S.-V/s. – Yallappa and Another.

CHARGE

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Yallappa S/o. Basappa Balurgi,
Aged: 48 years, Occ: Agriculture,
2. Boramma W/o. Yallappa Balurgi,
Aged: 45 years, Occ: Housewife,

Above both are R/o. Yalasangi village, Tq: Aland.

As follows;

Firstly, that on 13.08.2019 at 11:45 a.m., on the border of Madiyal village in land bearing Sy.No.60, within the limits of Nimbarga Police Station, the dispute of land bandar of you accused and CW1, when CW4 told you accused No.1, do not pluck the grass on the bandara of the said land, for that, you accused No.1 and 2 in furtherance of common intention, you accused No.1 intentionally insulted CW4 by abusing him in filthy language as “ಏ ರಂಡಿ ಮಗನಾ ನೀ ಯಾಕ ನನಗೆ ಹೇಳಿತಿ ನನ್ನ ಬಂದಾರಿ ಮೇಲಿಂದ ನಾನು ತೆಗಿತಿವಿ ನೀನು ಏನು ಸೆಂಟಾ ಕಿತ್ತುಕೊತಿ ಕಿತ್ತಿಕೊ” and thereby gave provocation to CW4 intending or knowing it likely that such provocation will cause him to break the public peace or to commit any other offence and thereby you have committed an

offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.1 pushed CW4 on the ground and voluntarily caused hurt to CW4 on his cheek with hand, you accused No.1 voluntarily caused hurt to CW1 on the back side of her neck and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Thirdly, that on above said date, time and place, you accused No.1 and 2 in furtherance of common intention, when CW5 came to pacify the quarrel, you accused No.1 voluntarily caused hurt to CW5 on her head with Khurphi (ಖುರಪಿ) and caused bleeding injury, if which is used as a weapon of offence is likely cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within my cognizance.

Fourthly, that on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.1 pulled the hairs of CW1, a woman intending to outrage her modesty or knowing fully well that the intended act is likely to outrage the modesty of the said woman and thereby you have committed an offence punishable U/Sec.354 R/w Sec.34 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, in furtherance of common intention you accused No.1 and 2, have

criminally intimidated CW1, CW4 and CW5 by threatening them to take away their lives saying as “ನಿಮಗೆ ಇವತ್ತು ಇಡಂಗಿಲ್ಲ ಖಲಾಸ ಮಾಡುತ್ತೇವೆ” so as to cause alarm in his mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
