hereby charge you,*

As follows;

Firstly, that on 31.03.2019 at 9:00 a.m., Parshwanath Colony at the outskirts of Aland Town, within the limits of Aland Police Station, you accused No.1 to 6 were members of an unlawful assembly, in prosecution of common object, in the house of you accused No.4 and 5, when CW1 along with CW2 and CW3 were raided on the above said house and seized the food-grains from the said house. You accused persons for your personal profit without obtaining permit or license, unofficially stored the food-grains of ration in the above said house of 612 – Packets of Rice weighing 306 Quintals of estimated cost of Rs.7,00,000/- and one electronic weighing machine estimated cost of Rs.5,000/- in your custody illegally, which were meant for distributing through public distribution system and thereby you have committed an offence punishable U/Sec.3, 6 R/w Sec.7 of Essential Commodities Act 1955, Sections 3, 4, 12, 18, 19 of Karnataka Essential Commodities [Public Distribution System] Public Control, Section 4, 5, 8 of Karnataka Essential Commodities [storage Accounts Maintaining Value Notification], within the cognizance of this Court.

Finally, that on the above said date, time and place, were members of an unlawful assembly, in prosecution of common object of you accused No.1 to 5, have cheated the government and ration card holders of the food-grains by dishonestly misused the above said food-grains and sold the food-grains at higher price as fixed by the Government and also transported to sell the above said food-grains to the other place and thereby you have committed an

offence punishable U/Sec.420 R/w. Section 149 of Indian Penal Code within my cognizance of this Court.

And I hereby direct that you be tried for the said offences by this court.
