C H A R G E

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Ismail S/o. Mahiboobsab Sayyad,
Aged: 38 years, Occ: Agriculture,
2. Irfan S/o. Mahiboobsab Sayyad,
Aged: 32 years, Occ: Agriculture,
3. Saleem S/o. Mahiboobsab Sayyad,
Aged: 30 years, Occ: Welding work,
4. Abeda W/o. Mahiboobsab Sayyad,
Aged: 55 years, Occ: Housewife,
5. Mahibbobsab Sayyad S/o. Adul Karim Sayyad,
Aged: 65 years, Occ: Agriculture,
Above all are R/o. Bandarwad Galli, Aland.
6. Irshad S/o. Mahammad Ali,
Aged: 24 years, Occ: Student,
R/o. Khaji Galli, Aland.
7. Abbas Ali S/o. Mohammad Javale,
Aged: 38 years, Occ: Business,
R/o. Khaji Mohalla, Aland.

As follows;

Firstly, that on 26.11.2022 at 9:30 p.m. near Tippu Chowk at Aland Town, within the limits of Aland Police Station, you accused No.1 to 7 being members of an unlawful assembly, in prosecution of common object, of the said assembly, namely, to commit rioting, to cause hurt, to intentionally insult and to criminally intimidated and thereby you have committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 7 being members of an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence and thereby you have committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly in prosecution of common object, came near the house of CW1 and you accused No.1 intentionally insulted CW1 by abusing him in filthy language as “ಏ ರಾಂಡಕೇ ಬೇಟೆ ತೆರೆಕೊ ಮಾರನೇಕೆಲಿಯೇ ಹಮ ಲೋಗೊ ಆಯೆ” and thereby gave provocation him and also intentionally insulted intending or knowing it to be likely that such provocation will cause him to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code, within my cognizance.

Fourthly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly, in

prosecution of common object, you accused No.1, 2, 5 and 7 wrongfully restrained the movement of CW1 from proceeding further with an intention to commit certain offenses and thereby you have committed an offense punishable U/Sec.341 R/w Sec.149 of Indian Penal Code, within my cognizance.

Fifthly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly in prosecution of common object, you accused No.1, 2, 5 and 7 voluntarily caused hurt to CW1 with hands, you accused No.4 voluntarily caused hurt to CW4 on her stomach and chest with hand and caused internal injury and thereby you have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code, within my cognizance,

Sixthly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly in prosecution of common object, you accused No.2 voluntarily caused hurt to CW1 on his arm with knife and caused bleeding injury, if which is used as a weapon of offence is likely cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.149 of Indian Penal Code, within my cognizance

Seventhly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly in prosecution of common object, you accused No.3 pulled the hands of CW4 and used criminal force to CW4 a woman with an intention to outrage her modesty and thereby you have committed an offence

punishable U/Sec.354 R/w Sec.149 of Indian Penal Code, within my cognizance.

Eighthly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly in prosecution of common object, you accused No.1 to 4 committed mischief by causing damage to the glass and cover of the Mahindra Jeep which was standing in front of their house and caused loss and thereby you have committed an offence punishable U/Sec.427 R/w Sec.149 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly in prosecution of common object, have criminally intimidated by threatening CW1 life as “ತೂ ಅಜ ಬಚ್ಚಗಯಾ ಆಗೇ ಮಿಲ್ ತೆರಿಕೋ ಖತಮ ಕರಕೆ ಜೋಡತೆ”, so as to cause alarm in his mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code, within my cognizance.

And I hereby direct that you be tried on the said charge.
