C H A R G E

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC
Aland, do hereby charge you,*

ACCUSED:

Basalingayya S/o. Shivayogappamath,
Aged: 66 years, Occ: Agriculture,
R/o. Jawali (D) village, Taluka Aland.

As follows;

Firstly, that on 25.03.2022 at 5:30 p.m. to 7:30 p.m. at
Jawali (D) village, within the limits of Nimbarga Police Station,

XXXXXXXXXXXXXXXXXXXXXXXXXXXX

knowing fully well that such act is an insult to the belief
of CW1 and others and thereby you accused has committed
an offence punishable U/Sec.295(A) of Indian Penal Code,
within the cognizance of this Court.

Secondly, that on the above said date, time and place,
you accused

and thereby you have committed an offence punishable
U/Sec.201 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused came there and intentionally insulted CW1, CW4 to CW6 by abusing them in filthy language stated that “ಏ ಕಬ್ಬಲಿಗೇರಾ ನೀವು ಜಾತ್ರಿ ಯಾವಾಗ ಮಾಡ್ತಿರಿ ನಿಮ್ಮೊನ ರಂಡಿ ಮಕ್ಕಳ್ಳಾ” “ರಂಡಿ ಮಕ್ಕಳ್ಳಾ ನಿಮ್ಮ ಕಬ್ಬಲಿಗೇರೆದು ಬಹಳ ನಡದಾದ ನಿಮ್ಮೊನ” intending or knowing it to be likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 of Indian Penal Code, within the cognizance of this Court.

And I hereby direct that you be tried on the said charge by this Court.
