SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that on 01.04.2022 at 8:30 p.m. on Chinchansoor-Kalaburagi main road, near the arch of Mahapura mother temple, within the limits of Narona Police Station, you accused No.1 and CW2 were traveling on Hero Company Splendor Plus BS-4 motorcycle bearing Reg.No.KA-32/EQ-7373, Chassis No.MBLHAR080HHH55482 and Engine No.HA10AGHHHH2127 of CW10 were going to

Kalaburagi, you accused No.2, 3 and CW3 were traveling on Hero Honda Passion Plus motorcycle bearing Reg.KA-25/EC-6695, Chassis No.MBLHA10EL99D23172 and Engine No.HA10EB99D202174 came from Chinchansoor Village, drove the same in a rash and negligent manners so as to endanger humans life and personal safety of others and dashed to the above said motorcycle of accused No.1 and caused injuries to CW2, CW3 and to accused No.2 due to which accused No.2 succumbed to those injuries and thereby you accused No.1 alongwith deceased accused No.2 and 3 have committed an offence punishable U/Sec.279 of Indian Penal Code and the same is within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused No.1 drove the above said vehicle in the above stated manner and caused the accident to CW2 and CW3 due to which they sustained grievous injuries and thereby you accused No.1 alongwith deceased accused No.2 and 3 have committed an offence punishable U/Sec.338 of Indian Penal Code and the same is within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused No.1 and 3 drove the above said vehicle in the above stated manner, caused the accident to accused No.2 due to which he succumbed to those injuries at hospital and thereby caused the death of the deceased by your above said rash and negligent act not amounting to culpable homicide and thereby you accused No.1 alongwith

deceased accused No.2 and 3 have committed an offence punishable U/Sec.304-A of Indian Penal Code and the same is within the cognizance of this Court.

It is further alleged that you accused No.3 being the owner of the above said offended vehicle has permitted accused No.2 to drive the said vehicle knowing fully well that he has no driving license to drive the said vehicle and thereby you accused No.3 has committed an offence punishable U/Sec.180 of IMV Act and the same is within the cognizance of this Court.

It is further alleged that you accused No.2 being the driver of the above said offended vehicle has drove the said vehicle without having valid to drive the said vehicle and thereby you accused No.2 has committed an offence punishable U/Sec.181 of IMV Act and the same is within the cognizance of this Court.

It is further alleged that you accused No.3 being the owner of the above said offended vehicle has permitted accused No.2 to drove the vehicle fully knowing well that the said vehicle does not possess valid insurance as on the date of the accident and thereby you accused No.1 alongwith deceased accused No.2 and 3 have committed an offence punishable U/Sec.196 of IMV Act and the same is within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused No.1 used fake number plate i.e. Hero Company Splendor Plus BS-4 motorcycle bearing re.No.KA-32/EL-8719 as genuine, dishonestly and fraudulently and thereby you accused No.1 has committed an offence punishable U/Sec.471 of Indian Penal Code and the same is within the cognizance of this Court.
