The State through Nimbarga P.S. –V/s. – Sharanabasappa

C H A R G E

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC
Aland, do hereby charge you,*

ACCUSED:

Sharanabasappa @ Shivasharanappa,
S/o. Hanamantaraya,
Aged: 40 years, Occ: Private work,
R/o. Hittal Shiroor village, Taluka Aland.

As follows;

Firstly, that on 16.02.2023 at 9:30 a.m. on the border of Hittal Shiroor village in the land of CW1 bearing Sy.No.245/3, within the limits of Nimbarga Police Station, when the CW1 and CW4 were in the said land, you accused has committed criminal trespass by entering into the above said land and thereby you have committed an offence punishable U/Sec.447 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused wrongfully restrained the movement of CW1 and CW4 when the crop was piling up in their land and to commit certain offence and thereby you have committed an

offence punishable U/Sec.341 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused intentionally insulted CW1 and CW4 by abusing them in filthy language and also you accused abused the CW1 stating as “રોડ” intending or knowing it to be likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 of Indian Penal Code, within the cognizance of this Court.

Fourthly, that on the above said date, time and place, you accused used criminal force against CW1 with an intention to outrage her modesty so also dragged her hairs a woman, intending to outrage her modesty or knowing fully well that the intended act is likely to outrage the modesty of the said woman and thereby you have committed an offence punishable U/Sec.354 of Indian Penal Code, within the cognizance of this Court.

Fifthly, that on the above said date, time and place, you accused slapped to the CW1, when the CW4 came to pacify the quarrel you accused slapped to the CW4 and thereby you have committed an offence punishable U/Sec.323 of Indian Penal Code, within the cognizance of this Court.

Finally, that on the above said date, time and place, you accused threatened CW1 and CW4 by threatening to take

away their lives as “ನಿಮಗೆ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ” with intent to cause alarm in their mind and thereby you have committed an offence punishable U/Sec.506 of Indian Penal Code, within the cognizance of this Court.

And I hereby direct that you be tried on the said charge by this Court.
