The State through Aland P.S.–V/s. – Neelakanth and Others

**CHARGE**

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

**ACCUSED:**

1. Neelakanth S/o. Renukaprasad Biradar,  
Aged: 29 years, Occ: Private Work,  
R/o.Padasavali. Now at Basaveshwar Nagar,  
Kalaburagi.
2. Renukaprasad S/o. Kalyani Biradar,  
Aged: 65 years, Occ: Agriculture,
3. Kamalabai W/o. Renukaprasad Biradar,  
Aged: 58 years, Occ: Agriculture,  
Both are R/o. Padasavali Village, Tq: Aland.
4. Vinayaka S/o. Chandrakanth Mulage,  
Aged: 22 years, Occ: Student,  
R/o. Chincholi. Now at Solapur.

As follows;

Firstly, on 12.02.2022 at 5:00 p.m., on the border of Padasavali Village, in land bearing Sy.No.40/3, within the limits of Aland Police Station, when CW1, 4 to 7 were working on the above survey number, you accused Nos.1 to 4 in furtherance of common intention, have committed criminal trespass by entering into the above said land of CW1 and thereby you have committed an offence

punishable U/Sec.447 R/w Sec.34 of Indian Penal Code and within my cognizance.

Secondly, that on the above said date, time and place, you accused Nos.1 to 4 in furtherance of common intention, you accused No.1 intentionally insulted C.W1 by abusing him in filthy language like “ಏ ರಂಡಿ ಮಗನೇ ನಿಮಗೆ ನವ್ಯ ಹೊಲದಲ್ಲಿ ಬರಬೇಡ ಬಂದಾರಿ ಹೊಡಿಬ್ಯಾಡ ಅಂತಾ ಎಷ್ಟು ಸಾರಿ ಹೇಳಿದರೂ ನೀನು ಮತ್ತೆ ಹಾಗೆ ಮಾಡಿ ಎದೆ ಉಬ್ಬಿಸುತ್ತಾ ಬರುತ್ತೇನು? ನಿನಗೆ ಒಂದು ಕೈ ನೋಡೆ ಬಿಡುತ್ತೇನೆ,” when CW5 asked the accused No.1 as on the same, you accused No.1 intentionally insulted CW5 by abusing her in filthy language stating that “ಏ ರಂಡಿ ಮಗಳೆ ನಿನಗೆ ಬಹಳ ಸೊಕ್ಕು ಬಂದಿಗಿ” and thereby gave provocation to CW1 and CW5 intending or knowing it likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code and within my cognizance.

Thirdly, that on above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.1 assaulted CW1 with a stone on his head and caused bleeding injury, accused No.4 assaulted CW1 with a stone on his head and caused bleeding injury, CW2 came to pacify the quarrel, you accused No.2 assaulted CW2 with a stone on his waist and caused internal injury, if which is used as a weapon of offence is likely cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code and within my cognizance.

Fourthly, that on the above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.2 voluntarily caused hurt to CW1 on his cheek and back with hands, you accused No.4 knocked him down on the ground, CW2 came to pacify the quarrel, you accused No.1 and 2 knocked him down and you accused No.1 slapped CW5 on her cheek and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code and within cognizance of this court.

Fifthly, that on above said date, time and place, you accused Nos.1 to 4 in furtherance of common intention, you accused No.1 pulled the saree of CW5 a woman intending to outrage her modesty or knowing fully well that the intended act is likely to outrage the modesty of the said woman and thereby you have committed an offence punishable U/Sec.354 R/w. Sec.34 of Indian Penal Code and within cognizance of this court.

Finally, that on the above said date, time and place, you accused Nos.1 to 4 in furtherance of common intention, you accused Nos.3 criminally intimidated CW1, CW4, CW5 & CW7 by threatening to take away their lives saying that “ಈ ನನ್ನ ಹಾಟ್ಕಾನ ಮಕ್ಕಳದು ಕಿರಿಕಿರಿ ಬಹಳ ಒಜ್ಜಿಯಾಗಿದೆ ಸರಿಯಾಗಿ ಸಿಕ್ಕಿದ್ದಾರೆ ಹೊಡಿರಿ” so as to cause alarm in their mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code and within cognizance of this court.

And I hereby direct that you be tried on the said charge.
