SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that on 12.05.2023 at 8:30 p.m. on Chinchansoor-Kalaburagi main road, on the border of Chinchansoor, near Mutyanawari, on road, within the limits of Naron Police Station, the husband of CW1 Mahadevappa S/o. Babu Kobala and the husband of CW11 Peerappa S/o. Saibanna Doddamani were traveling from Chinchansoor Village to their village on his motorcycle bearing Reg.No.MH-14/AY-9592, you accused being the driver of the Hero Splendor Plus motorcycle bearing registration No.KA-32/HC-1305 came from opposite side, in high speed and rash and negligent manner so as to endanger human life and personal safety of others and dashed to the above said motorcycle which caused injuries to Mahadevappa and Peerappa and thereby you accused has committed an offence punishable U/Sec.279 of Indian Penal Code and the same is within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused drove the above said vehicle in the above stated manner and caused the accident to Mahadevappa and Peerappa, Mahadevappa due to which, he sustained internal and bleeding injuries on the spot and Peerappa due to which sustained internal and bleeding injuries in hospital and succumbed to those injuries and thereby caused the death of the deceased by your above said rash and negligent act not amounting to culpable homicide and thereby you accused has committed an offence punishable U/Sec.304-A of Indian Penal Code and the same is within the cognizance of this Court.

It is further alleged by the prosecution that, on the above said date, time and place, you accused drove the above said vehicle in the above stated manner, caused the accident and after the accident you accused ran away from the spot without intimating the accident to the nearest police station or taking the injured to the hospital for their treatment and thereby you accused has committed offence punishable U/Sec.187 of IMV Act and the same is within the cognizance of this Court.
