State by Aland P.S. V/s Kashibai & Others

CHARGE

I, Smt. Suman Chittargi B.Com., LL.M., PRL. Civil Judge & JMFC, Aland, do hereby charge you:

1. Kashibai W/o Mahadevappa Patil,
Aged: 50 years, Occ: Household,
2. Mahadevappa S/o. Mallikarjun Patil,
Aged: 60 years, Occ: Agriculture,
3. Umesh S/o. Shankarrao Kulkarni,
Aged: 50 years, Occ: Agriculture,
4. Siddaram S/o Mahadevappa Patil,
Aged: 27 years, Occ: Agriculture,

Above all are R/o. Khanapur Village,
Tq: Aland.

That, you on accused No.1 to 4 on 19.10.2024 at about 7.30 P.M. at Khanapur village, which comes within the jurisdiction of Aland Police Station, the dispute between the complainant and accused persons with regard to the bad smell coming from the bathroom, you accused No.1 intentionally insulted CW1 by abusing in filthy words such as " ನಮ್ಮದು ಬಹಳ ಅಗಿದೆ ಬೋಸಡಿ, ರಂಡಿ" and you accused

No.2, 3 and 5 came to the spot and intentionally insulted CW1 by abusing in filthy language words such as “ಇವರದು ಬಹಳ ಅಗಿದೆ” provoked the C.W.1, intending that such provocation would cause her to break the public peace and thereby committed an offence punishable under Section 352 R/w 190 of BNS and within my cognizance.

That, on the above said date, time and place, you accused No.1 to 4 in prosecution of your common object, you all accused persons picked up quarrel with the informant, and you accused No.1 used criminal force on the C.W.4 with an intention to outraged her modesty and thereby committed an offence punishable under Section 74 R/w 190 of BNS and within my cognizance.

That, on the above said date, time and place, you accused No.1 to 4 in prosecution of your common object, you all accused persons picked up quarrel with the informant, you accused No.1 voluntarily assaulted with hands to the informant on her chest and you accused No.2 kicked the CW1 and thereby committed an offence punishable under Section 115(2) R/w 190 of BNS and within my cognizance.

That, on the above said date, time and place, you accused No.1 to 4 in prosecution of your common object, you all accused persons picked up quarrel with the informant, you accused No.2

voluntarily assaulted with club to the informant, you accused No.4 voluntarily assaulted with brick to the CW1, you accused No.3 voluntarily assaulted with brick to the CW1, if such object is used as weapons of offence and the same is contacted on the chest, shoulders of CW1, due to which she has sustained grievous injuries and thereby committed an offence punishable under Section 118(2) R/w 190 of BNS and within my cognizance.

That, on the above said date, time and place, you accused No.1 to 4 in prosecution of your common object, you all accused persons picked up quarrel with the informant, and threatened her so as to cause alarm in her mind by committing an act of criminal intimidation and thereby committed an offence punishable under Section 351(2) R/w 190 of BNS and within my cognizance.

And I hereby direct that, you be tried for the said offences.
