State by Aland P.S. V/s Eshwar.

CHARGE

I, Smt. Suman Chittargi B.Com., LL.M., Prl. Civil Judge & JMFC, Aland, do hereby charge you:

Eshwar S/o Manik Pawar,
Age: 38 years, Occ: Coolie, R/o.
Teerth Village, Tq: Aland, Dist:
Kalaburagi.

.....as under:

It is alleged against the accused that the marriage of the informant by name Jayashree performed with you accused about 17 years back at Teerth Tanda of Aland Taluk. Due to wedlock she begotten three children i.e. Thrisha, Tanvi and Ayush and when she carrying 6 month of fourth Child in her whom at that time, you accused subjected her to dowry harassment by demanding to provide money to fulfilled bad vices of you and subjected her to the physical torture and mental agony by assaulting and by abusing her in filthy words and thereby committed an offence punishable under section 498(A) of IPC and within my cognizance.

That you on 16.02.2024 at about 9:00 a.m. when the informant had been to attend the agricultural work in the land

belonging to Gopi S/o Devalu Rathod of Teerth Tanda which comes within the jurisdiction of Aland police station, you accused came over there picked up quarrel with her by abusing her in filthy language such as “ಏ ರಂಡಿ ನನಗೆ ಕುಡಿಯಲು ಹಣ ಕೊಡು” provoked her intending that such provocation would cause her to break the public peace and thereby committed an offence punishable under Section 504 of IPC and within my cognizance.

That you on the above said date, time and place, during the course of same transaction, you accused picked up quarrel with the informant and voluntarily assaulted with stick on her head and back and caused internal injury and used the said stick as weapon in causing injury and thereby committed an offence punishable U/sec.324 of IPC and within my cognizance.

That you on the above said date, time and place, during the course of same transaction, you accused picked up quarrel with the informant and voluntarily assaulted with bare hands on her person and caused internal injury and thereby committed an offence punishable U/sec.323 of IPC and within my cognizance.

That you on above said date time and place during course of same transaction, you accused picked up quarrel with the informant and threatened to her life with dire consequences by

contending that “ನನಗೆ ಹಣ ಕೊಟ್ಟಿಲ್ಲ ಅಂದರೆ ನನಗೆ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ” and caused alarm in her mind by committing an act of criminal intimidation and thereby committed an offence punishable under Sec. 506 of Indian Penal Code and within my cognizance.

And I hereby direct that, you be tried for the said offences.
