**SUBSTANCE OF ACCUSATION**

It is alleged by the prosecution that, on 24.12.2024 at about 21.30 hours on Wagadhari-Ribban Palli National Highway road No.10 near the land of Babusab, you accused being the driver of Commender Jeep bearing Reg.No.KA-17/M-3563, drove it in high speed and in a rash and negligent manner so as to endanger human life and personal safety of others and lost control over it and caused accident and thereby you accused has committed an offence punishable U/Sec.281 of BNS and the same is within the cognizance of this Court.

That you, on the above said date, time and place you accused being the driver of above mentioned offending car, drove it in high speed and in rash and negligent manner and dashed against on coming motorcycle bearing Reg.KA32/HE-7916 resulting in caused grievous injuries to pillion rider CW2 and thereby committed an offence punishable

U/Sec.125(b) of BNS and the same is within the cognizance of this Court.

That you, on the above said date, time and place you accused being the driver of above mentioned offending car drove it in high speed and in rash and negligent manner and dashed against oncoming above mentioned victim motorcycle and thereby caused multiple grievous injuries to the rider by name Parameshwar S/o Hanamant Godke ultimately who succumbed to those injuries without responding to the treatment at the GIMS, Kalaburagi which is not amounting to culpable homicide and thereby committed an offence punishable U/Sec.106 of BNS and the same is within the cognizance of this Court.

That you on above said date, time and place, you accused being the driver of above said offending Jeep caused accident to the victim's motorcycle, after the accident fleeaway from the spot without providing first aid to the injury so also without intimidating about factum of accident to the nearest police station and thereby committed an offence punishable U/Sec.187 of Motor Vehicle Act and the same is within the cognizance of this Court.
