SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that on 03.02.2021 at 7:30 p.m. on Aland – Kalaburagi Road, in front of APMC office, within the limits of Aland Police Station, when the son of CW1 by name Vinodkumar was going to Aland bus stand after completing his work, at that time you accused No.1 being the driver of vehicle lorry bearing Reg.No.KA-28-C-7665, drove the same in a so rash and negligent manner as to endanger human life and personal safety of others and dashed to the son of CW1 by name Vinodkumar and thereby

you have committed an offence punishable U/Sec.279 of Indian Penal Code, within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused No.1 drove the above said vehicle in the above stated manner, caused the accident to the son of CW1 by name Vinodkumar due to which Vinodkumar sustained grievous injuries to his vital parts of the bodies and grievous internal injuries and succumbed to those injuries on the spot and thereby caused the death of the deceased Babu by your above said rash and negligent act not amounting to culpable homicide and thereby you have committed an offence punishable U/Sec.304-A of Indian Penal Code, within the cognizance of this court.

It is further alleged that on the above said date, time and place, you accused No.1 being the driver of the above said vehicle by driving the same in the above said manner and after causing the above said injuries to the injured and deceased, failed to inform the fact of accident to the nearest police station and failed to take reasonable steps to secure medical attention for the injured person and ran away from the spot and thereby you have committed an offence punishable U/Sec.187 of Motor Vehicles Act, within the cognizance of this Court.

It is further alleged that you accused No.1 being the driver of the above said offended vehicle has drove the vehicle

and you accused No.2 being the owner of the above said offended vehicle has permitted accused No.1 to drove the vehicle fully knowing well that the said vehicle does not possess valid insurance as on the date of the accident and thereby you have committed an offence punishable U/Sec.196 of Motor Vehicles Act, within the cognizance of this Court.
