The State through Aland P.S.-V/s. – Hanamanth and Another

**CHARGE**

I, **YALLAPPA KALLAPUR**, *Prl. Civil Judge & JMFC Aland*, do  
*hereby charge you,*

**ACCUSED:**

1. Hanamanth S/o. Shivappa Warik,  
Aged: 19 years, Occ: Agriculture,
  2. Bheemashankar S/o. Karabasappa Talawar,  
Aged: 37 years, Occ: Agriculture,
- Above both are R/o. Khajuri village, Taluka Aland.

As follows;

Firstly, that on 03.09.2022 at 10:00 p.m. at Khajuri village, within the limits of Aland Police Station, when CW1 and CW6 came near the house of you accused No.1 and asked where is your father, for that you accused No.1 and 2 in furtherance of common intention, have intentionally insulted CW1 and CW6 by abusing them in filthy language as “ಏ ರಂಡಿ ಮಕ್ಕಳೆ ನೀವು ನಮ್ಮ ಮನೆಗೆ ಕೇಳಲು ಬರುತ್ತೀರಿ” thereby gave provocation to CW1 and CW6 intending or knowing it likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, in furtherance of common intention of you accused No.1 and 2, have criminally intimidated CW1 and CW6 by threatening to take away their lives stated that “ನೀವು ಇನ್ನೊಮ್ಮೆ ನಮ್ಮ ಮನೆಯ ಹತ್ತಿರ ಬಂದಲ್ಲಿ ನಿಮಗೆ ಶೂಟ್ ಮಾಡಿ ಖಲಾಸ ಮಾಡುತ್ತೇವೆ”, so as to cause alarm in their mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Finally, that on the above said date, time and place, in furtherance of common intention of you accused No.1 and 2, were in possession and carrying the Fire-arm i.e. “ಒಂದು ಕಂಟ್ರಿಮೇಡ ಪಿಸ್ತೂಲ” in contravention of Sec.3 & 7 without having licence for acquisition and possession of firearm and thereby you have committed an offence punishable U/Sec.25, 27 of Indian Arms Act 1969 and within my cognizance.

And I hereby direct that you be tried on the said charge.
