**C H A R G E**

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC  
Aland, do hereby charge you,*

**ACCUSED:**

Waseem @ Waseem S/o. Saifan Javali,  
Aged: 27 years, Occ: Business,  
R/o. Sonagalli Aland, Taluka Aland.

As follows;

Firstly, that on 31.05.2023 at 4:30 p.m. at Sonar Galli at Aland, within the limits of Aland Police Station, the CW1 and CW4 are the employees of GESCOM have come to the house of you accused and asked to pay electricity bill otherwise they will cut the electricity connection, on that time you accused refused to pay the bill and intentionally insulted CW4 by abusing him in filthy language stated as “ರಾಂಡಕೆ ಬೇಟೆ ಮೇರಾ ಘರ ಕಾ ಲೈನ್ ಕಟ್ ಕರತೆ” intending or knowing it to be likely that such provocation will cause him to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 of Indian Penal Code, within the cognizance of this Court.

Secondly, that on the above said date, time and place, you accused used criminal force on CW4 by way of assaulting with hand and abused him in filthy language when CW4 was on his duty, with an intention to prevent or deter and discharging his duty as a public servant and thereby you have committed an offence punishable U/Sec.353 R/w Sec.34 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused, picked up quarrel with CW1 and CW4 voluntarily assaulted them with stone and brick to deter the said public servant from discharging of their duty and thereby you have committed an offence punishable U/Sec.332 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused threatened CW4 by threatening him to take away his life, with intent to cause alarm in his mind and thereby you have committed an offence punishable U/Sec.506 of Indian Penal Code, within the cognizance of this Court.

And I hereby direct that you be tried on the said charge by this Court.
