*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Basavaraj S/o. Revappa Kantle,
Aged: 60 years, Occ: Agriculture,
2. Udaykumar S/o. Basavaraj Kantle,
Aged: 24 years, Occ: Agriculture,
3. Ravikiran S/o. Basavaraj Kantle,
Aged: 29 years, Occ: Agriculture,
4. Shirish @ Shrishail, S/o. Basavaraj Kantle,
Aged: 20 years, Occ: Agriculture,
5. Chandrakanth S/o. Revappa Kantle,
Aged: 70 years, Occ: Agriculture,
6. Shivanand S/o. Chandrakanth Kantle,
Aged: 35 years, Occ: Agriculture,
7. Mallikarjun S/o. Chandrakanth Kantle,
Aged: 30 years, Occ: Agriculture,

Above all are R/o. Khajuri village, Tq: Aland.

As follows;

Firstly, that on 03.05.2021 at 6.30 a.m. at Khajuri village, within the limits of Aland Police Station, when CW1 was sweeping in front of her house, you accused No.1 to 7 came there formed an

unlawful assembly and in prosecution of common object of the said assembly, namely, to commit rioting, to cause hurt, to intentionally insult and to criminally intimidated and thereby you have committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 7 being members of an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence and thereby you have committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly in prosecution of common object, you accused No.1 intentionally insulted CW1 by abusing her in filthy language like "ಏ ರಂಡಿ ನಿನ್ನ ಗಂಡನಿಗೆ ಹೊಲದ ವಿಷಯದಲ್ಲಿ ಯಾಕೆ ಪಂಚಾಯತಿ ಮಾಡಬೇಕು", you accused No.3 and 4 intentionally insulted CW1 by abusing her in filthy language like "ಏ ರಂಡಿ ಹೊರಗೆ ಬಾ", when CW4 came to pacify quarrel, you accused No.5 intentionally insulted CW1 by abusing her in filthy language like "ಏ ರಂಡಿ ಮಗನೇ ಎಲ್ಲಿಗೆ ಹೋಗುತ್ತಿ" thereby gave provocation to them and also intentionally insulted intending or knowing it to be likely that such provocation will cause CW2 and CW5 to break the public peace or to commit any other offence and thereby you have

committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code, within my cognizance.

Fourthly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly, in prosecution of common object, you accused No.1 wrongfully restrained the movement of CW1 from proceeding further and you accused No.5 wrongfully restrained the movement of CW4 from proceeding further with an intention to commit certain offences and thereby you have committed an offence punishable U/Sec.341 R/w Sec.149 of Indian Penal Code, within my cognizance

Fifthly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly, in prosecution of common object, you accused No.2 slapped on the cheek of CW1 and thereby you have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code, within my cognizance.

Sixthly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly, in prosecution of common object, you accused No.6 and 7 voluntarily caused hurt to CW4 on his back with club and caused internal pain, if which is used as weapon of offence is likely cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.149 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, were members of an unlawful assembly in prosecution of common object

of you accused No.1 to 7, have criminally intimidated by threatening CW1 and CW4 lives as “ಇನ್ನೊಮ್ಮೆ ಹೊಲದ ಕಡೆಗೆ ಬಂದರೆ ನಿಮ್ಮ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ” so as to cause alarm in his mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code, within my cognizance.

And I hereby direct that you be tried on the said charge.
