The State through Nimbarga P.S.-V/s. – Baburao and Others.

CHARGE

I, **YALLAPPA KALLAPUR**, *Prl. Civil Judge & JMFC Aland*, do
hereby charge you,

ACCUSED:

1. Baburao S/o. Devarao Patil,
Aged: 70 years, Occ: Agriculture,
2. Prabhakar S/o. Baburao Patil,
Aged: 30 years, Occ: Agriculture,
3. Shankar S/o. Baburao patil,
Aged: 25 years, Occ: Agriculture,
4. Mahadevi W/o. Baburao Patil,
Aged: 65 years, Occ: Housewife,

Above all are R/o. Madiyal village, Taluka Aland.

As follows;

Firstly, that on 09.02.2022 at 12:30 p.m. at near the Bus Stand at Madiyal village, within the limits of Nimbarga Police Station, when CW1, CW4 and CW5 were going to their land, you accused No.1 to 4 in furtherance of common intention, you accused No.1 and 2 intentionally insulted CW1 and CW5 by abusing them in filthy language as “ಎ ರಂಡ್ಯಾರ ಎಲ್ಲಿಗಿ ಹೊಂಟರಿ” and you accused No.2 intentionally insulted CW5 by abusing her in filthy language “ಎ ರಂಡಿ” thereby gave provocation to CW1 and CW5 intending or knowing it likely that such provocation will cause them to break

the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.1 pulled hairs of CW1, a woman intending to outrage her modesty or knowing fully well that the intended act is likely to outrage the modesty of the said woman and thereby you have committed an offence punishable U/Sec.354 R/w Sec.34 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.1 pushed the CW1 on the ground and caused the bleeding injury on her left hand, you accused No.4 slapped on the cheek of CW5, you accused No.1 slapped on the right cheek of CW7 and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Fourthly, that on above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.1 voluntarily caused hurt to CW7 on his back and head with stone, you accused No.3 voluntarily caused hurt to CW6 on his head, right eye and left leg thigh with club, which it used as a weapon of offence, is likely to cause death and thereby you have

committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within my cognizance.

Fifthly, that on above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.1 and 2 wrongfully restrained the movement of CW5, CW6 and CW7 from proceeding further and to commit certain offence and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.3 and 4 criminally intimidated CW5 by threatening to take away her life stated that “ಈ ರಂಡಿಗೆ ಬಿಡಬೇಡ”, so as to cause alarm in her mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
