SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that, on 08.12.2023 at about 4-20 pm on Waghadari-Ribbanpalli State Highway Road, near the land of CW5, on public road, which comes within the limits of Aland police station, when the CW-4 was moving on motor cycle bearing No.KA-32/S-7125 near the land of CW5 alongwith pillion rider by name deceased Mallinath S/o Amrutrao Biradar at that time, you accused being the driver of Bolero bearing No.MH-25/R-1906 drove it in high speed and in a rash and negligent manner so as to endanger human life and personal safety of others and caused accident and thereby you have committed an offence punishable U/Sec.279 of Indian Penal Code and the same is within the cognizance of this Court.

That on the above said date, place and time, you accused being the driver of the offending Bolero, drove it in high speed and in negligent manner so as to endanger human life or personal safety of others and dashed to the above mentioned victim motorcycle and resulting in caused head

injury and grievous injuries to the hands and legs of CW4 and thereby committed offences punishable U/s.338 of IPC and within my cognizance.

That on the above said date, place and time, you accused being the driver of the offending Cruiser, drove it in high speed and in negligent manner so as to endanger human life or personal safety of others and dashed to the above mentioned victim motorcycle and resulting in and caused grievous injuries to the pillion rider by name Mallinath S/o Amrutrao Biradar has sustained multiple grievous injuries and has succumbed to those injuries while shifting to the Gangamai Hospital, Solapur without responding to the medical aid, which is not amounting to culpable homicide and thereby committed offences punishable U/s.304(A) of IPC and within my cognizance.

It is further alleged by the prosecution that, on the above said date, time and place, you accused driver of the above mentioned offending vehicle drove the same in rash and negligent manner, due to such act caused the accident and after the accident the you accused ran away from the spot without providing first aid to the injured and without intimating about the factum of accident to the nearest police station and thereby you accused has committed offence punishable U/Sec.187 of IMV Act and the same is within the cognizance of this Court.
