**I, Smt. Suman Chittargi B.Com., LL.M., Prl. Civil Judge & JMFC, Aland, do hereby charge you:**

**ACCUSED:**

All are R/o Tadakal Road, Vithal Nagar, Aland.

Aged: 36 years, Occ: Coolie,  
R/o Honnalli Tanda, Tq: Aland, Dist: Kalaburagi.

Aged: 27 years,

As follows:

That you accused No.1 to 8 on 12.02.2025 at about midnight 1:00 A.M. at Honnali village, near Ambhabhavani temple, which comes within the jurisdiction of Aland Police Station, when the CW1 and 4 to 11 have attended the fair(Jaatra) at that time, having ill-intention with regard to attending of fair by the C.W.1 you accused persons picked up quarrel with them, you all accused persons formed yourself into an unlawful assembly assembled together with an intention to commit certain offences and thereby you have committed an offence punishable U/Sec.189(2) R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 8 in prosecution of your common object, you all accused persons formed yourself into an unlawful assembly assembled together with an intention to commit certain offences and thereby committed an act of rioting with deadly weapons and thereby you have committed an offence punishable U/Sec.191(2) and 191(3) R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 8 in prosecution of your common object, you all accused persons picked up quarrel with the informant, you accused No.2 to

8 assaulted to the CW1 with hands on her cheek and pushed her towards earth and kicked on her back and chest and thereby caused internal injury to her and thereby you have committed an offence punishable U/Sec.115(2) and 118(1) R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 8 in prosecution of your common object, you all accused persons picked up quarrel with the informant, you accused No.4 and 5 intentionally insulted CW1 and 8 to 11 by abusing in filthy words as “ಏ ರಂಡೆರೆ ” provoked them intending that such provocation would cause them to break the public peace and thereby you have committed an offence punishable U/Sec.352 R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 8 in prosecution of your common object, you all accused persons picked up quarrel with the informant and CW4 to 11 threatened them by contending that “ಇನ್ನೋಮ್ಮ ನಮ್ಮ ತಂಟೆಗೆ ತಕರಾರಗೆ ಬಂದರೆ ನಿಮ್ಮ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ” with dire consequence so as to cause alarm in their mind by committing an act of criminal intimidation and thereby you have committed an offence punishable U/Sec.351(2) R/w Sec.190 of BNS, within the cognizance of this Court.

And I hereby direct that you be tried on the said charge by this Court.
