C H A R G E

I, SNEHA PATIL., Addl. Civil Judge & JMFC, Aland, do hereby charge you, as follows;

Firstly, that on 20.03.2022 at 7:30 p.m. at Madaki Village, in front of the Laxmi Temple, near Government School, within the limits of Narona Police Station, you accused No.1 to 3 alongwith Mohan S/o. Mallikarjun Holakar abused CW1, CW4 to CW6 in filthy language and thereby gave provocation to them intending or

knowing it likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you accused No.1 to 3 alongwith Mohan S/o. Mallikarjun Holakar in furtherance of common intention have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code and the same is within the cognizance of this Court.

Secondly, on the above said date, time and place, you accused No.1 pulled the shirt of CW1, slapped CW1 and also kicked him, CW5 and CW6 came to pacified the quarrel, you accused No.2, 3 alongwith Mohan voluntarily caused hurt to CW6 on her cheek and back with hands and also kicked her and caused internal injury and you accused No.2 kicked CW6 and thereby you accused No.1 to 3 alongwith Mohan S/o. Mallikarjun Holakar in furtherance of common intention have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code and the same is within the cognizance of this Court.

Thirdly, on the above said date, time and place, you accused No.1 to 3 alongwith Mohan S/o. Mallikarjun Holakar wrongfully restrained CW1, CW5 and CW6 from proceeding in any direction in which they have right to proceed and thereby you accused No.1 to 3 alongwith Mohan S/o. Mallikarjun Holakar in furtherance of common intention have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code and the same is within the cognizance of this Court.

Fourthly, that on the above said date, time and place, you accused No.1 pulled the hair and saree of CW4, you accused No.3 pulled the hands and saree of CW6 and you accused No.4 pulled the hair of CW6, a woman intending to outrage their modesty or knowing fully well that the intended act is likely to outrage the modesty of the said woman and thereby you accused No.1 to 3 alongwith Mohan S/o. Mallikarjun Holakar in furtherance of common intention have committed an offence punishable U/Sec.354 R/w Sec.34 of Indian Penal Code and the same is within the cognizance of this Court.

Lastly, on the above said date, time and place, you accused No.1 to 3 alongwith Mohan S/o. Mallikarjun Holakar criminally intimidated CW1, CW4 to CW6 by threatening to take away their life so as to cause alarm in their mind and thereby you accused No.1 to 3 alongwith Mohan S/o. Mallikarjun Holakar in furtherance of common intention have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code and the same is within the cognizance of this Court.
