CHARGE

I, YALLAPPA KALLAPUR, Prl. Civil Judge & JMFC Aland, do hereby charge you,

ACCUSED:

Aged: 60 years, Occ: Agriculture,

Aged: 21 years, Occ: Agriculture,
3. Yallaling S/o. Shrimanth Metri,
Aged: 24 years, Occ: Agriculture,
4. Sharanappa S/o. Laxman Metri,
Aged: 26 years, Occ: Driver,
5. Akash S/o. Rajendra Metri,
Aged: 23 years, Occ: Agriculture,
6. Eramma W/o. Dattu Metri,
Aged: 37 years, Occ: Housewife,
7. Shivanand S/o. Bhimasha Metri,
Aged: 37 years, Occ: Coolie,
8. Mahananda W/o. Shrimanth Metri,

Above all are R/o. Koralli village, Tq: Aland.

As follows;

Firstly, that on 23.06.2023 at 9:15 a.m. at Koralli village in front of the house of CW1, within the limits of Aland Police Station, you accused No.1 to 12 by forming an unlawful assembly and in prosecution of common object of the said assembly, namely, to commit rioting, to cause hurt, to intentionally insult and to criminally intimidated and thereby you have committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 12 being members of an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence and thereby you have committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 12 being members of an unlawful assembly, in

prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence, you the accused were armed with clubs and stone and thereby you have committed an offence punishable U/Sec.148 R/w Sec.149 of Indian Penal Code and within my cognizance.

Fourthly, that on the above said date, time and place, were members of an unlawful assembly in prosecution of common object you accused No.1 to 12, have intentionally insulted CW1 and CW4 by abusing them in filthy language as “ಏ ರಂಡಿ ಮಕ್ಕಳೆ ಸೂಳೆ ಮಕ್ಕಳೆ”and thereby gave provocation to him and also intentionally insulted intending or knowing it to be likely that such provocation will cause CW1, CW4 and CW5 to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code and within my cognizance.

Fifthly, that on the above said date, time and place, you accused No.1 to 12 were members of an unlawful assembly, in prosecution of common object, you accused No.1 and 3 wrongfully restrained the movement of CW4 from proceeding further with an intention to commit certain offenses and thereby you have committed an offense punishable U/Sec.341 R/w Sec.149 of Indian Penal Code, within my cognizance.

Sixthly, that on the above said date, time and place, you accused No.1 to 12 were members of an unlawful assembly in prosecution of common object, you accused No.2 and 3 voluntarily

caused hurt to CW5 with hand, you accused No.10 kicked the CW1 on her stomach and thereby you have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code, within my cognizance,

Seventhly, that on the above said date, time and place, you accused No.1 to 12 were members of an unlawful assembly, in prosecution of common object, you accused No.3 voluntarily caused hurt to CW4 on his right eyebrow and caused bleeding injuries, you accused No.1 voluntarily caused hurt to CW4 on his head with club and caused bleeding injuries, you accused No.5 voluntarily caused hurt to CW5 on his forehead with stone and caused bleeding injuries, you accused No.6 voluntarily caused hurt to CW7 on his head with stone and caused bleeding injuries, if which are used as a weapons of offence is likely cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.149 of Indian Penal Code, within my cognizance.

Eighthly, that on the above said date, time and place, you accused No.1 to 12 were members of an unlawful assembly, in prosecution of common object, you accused No.7 pulled the hands of CW6 and used criminal force to CW6, a woman with an intention to outrage her modesty and thereby you have committed an offence punishable U/Sec.354 R/w Sec.149 of Indian Penal Code and within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 to 12 were members of an unlawful assembly, in prosecution of common object, have criminally intimidated by threatening CW1, CW4 to CW6 lives as “ನಮ್ಮ ತಂಟೆಗೆ ಬಂದರೆ ನಿಮಗೆ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ” so as to cause alarm in their mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code, within my cognizance.

And I hereby direct that you be tried on the said charge.
