*I, **YALLAPPA KALLAPUR**, C/c. Addl. Civil Judge & JMFC  
Aland, do hereby charge you,*

**ACCUSED:**

1. Yallappa S/o. Tammanna Maragammakoli,  
Aged: 42 years, Occ: Coolie,  
R/o. Nimbarga village, Taluka Aland.
2. Annappa S/o. Tammanna Maragammakoli,  
Aged: 50 years, Occ: Coolie,  
R/o. Sarasamba village, Taluka Aland.
3. Basavaraj @ Basappa  
S/o. Tammanna Maragammakoli  
Aged: 30 years, Occ: Coolie,  
R/o. Nimbarga village, Taluka Aland.
4. Ramesh S/o. Tammanna Maragammakoli,  
Aged: 29 years, Occ: Coolie,  
R/o. Nimbarga village, Taluka Aland.
5. Manik S/o. Balappa Maragammakoli,  
Aged: 50 years, Occ: Coolie,  
R/o. Jawali (D) village, Taluka Aland.

As follows;

Firstly, that on 28.04.2022 at 4:00 p.m. at Madan Hipparaga village, within the limits of Madan Hipparaga Police Station, when CW1 and CW4 to CW6 were going to Tea Point on a road in front of the bus stand of the said village, you accused No.1 to 5 in furtherance of common intention, you accused No.1 intentionally insulted CW1 by abusing him in filthy language as “ಏ ಭೋಸಡಿ ಮಗನೇ ಭೀಮಶಾ”, you accused No.2 intentionally insulted CW1 by abusing him in filthy language as “ಭೋಸಡಿ ಮಗನೇ” and thereby gave provocation to CW1 intending or knowing it likely that such provocation will cause CW1 to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 5 in furtherance of common intention, you accused No.2 has wrongfully restrained the movement of CW1 from proceeding further and to commit certain offence and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 5 in furtherance of common intention, you accused No.2 voluntarily caused hurt to CW1 on his cheek with hand, you accused No.1 and 2 pushed CW1 on the ground and kicked on him with leg and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Fourthly, that on the above said date, time and place, you accused No.1 to 5 in furtherance of common intention, you accused No.1 voluntarily caused hurt to CW1 on his waist with stone and caused internal pain, if which is used as a weapon of offence is likely to cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within my cognizance.

Fifthly, that on the above said date, time and place, you accused No.1 to 5 in furtherance of common intention, you accused No.3 to 5 criminally intimidated CW1 by threatening to take away his life stated that “ಇನ್ನೊಮ್ಮೆ ನಮ್ಮ ತಂಟೆಗೆ ಬಂದರೆ ಖಲಾಸ ಮಾಡಿಸುತ್ತೇವೆ”, so as to cause alarm in his mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Finally, that on the above said date, time and place, you accused No.1 to 5 in furtherance of common intention, you accused No.3 to 5 abetted the other accused persons in the commission of the above said offences, which were committed by you accused No.3 to 5 in consequence of your abatement and thereby you have committed an offence punishable U/Sec.109 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
