C H A R G E

I, YALLAPPA KALLAPUR, Prl. Civil Judge & JMFC Aland, do hereby charge you,

ACCUSED:

1. Shrimanth S/o. Bhutali Ghodake,
Aged: 55 years, Occ: Social Service,
2. Smt. Ambabai W/o. Chidanand Ghodake,
Aged: 43 years, Occ: Agri. & Household.

Above both are R/o.Savaleshwar Village,Tq: Aland.

As follows;

Firstly, that on 29.09.2021 at 7:00 a.m. at Savaleshwar Village, in front of the house of CW1, within the limits of Aland Police Station, when CW1 was cleaning the garbage, you accused No.1 and 2 picked up quarrel with previous enmity, in furtherance of common intention, you accused No.1 intentionally insulted CW1 by abusing her in filthy language as “ಏ ರಂಡಿ ಇಲ್ಲಿಯೇನು ಶೆಂತಾ ಕಸ ಹೊಡಿಯುತ್ತಿ ಬೋಸಡಿ ನಿನಗೆ ಬಹಳ ಸೊಕ್ಕ ಬಂದಿದಗೆ ನಿಮಗೆ ಒಂದು ಕೈ ನೋಡಬೇಕಾಗಿದೆ” and you accused No.2 intentionally insulted CW1 by abusing her in filthy language as “ಏ ರಂಡಿ ನೀವು ನಮ್ಮ ಛತ್ತ ಹಾಕುವ ಗೋಡೆಯ ಮೇಲೆ ಯಾಕೆ ಪತ್ರ ಹಾಕಬೇಕು, ಹಾದರಗಿತ್ತಿ” and thereby gave provocation to CW1 intending or knowing it likely that such provocation will cause her to break the

public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.1 voluntarily caused hurt to CW1 with a stone on her left eyebrow and below her right eye and caused bleeding injury, which it used as a weapon of offence, is likely to cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within my cognizance.

Thirdly, that on above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.2 wrongfully restrained the movement of CW1 from proceeding further and to commit certain offence and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code, within my cognizance.

Fourthly, that on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.2 slapped CW1 with hands and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Finally, that on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, when CW4 came to pacify the quarrel, you accused No.1 criminally intimidated CW1 and CW4 by threatening to take away their lives stated that “ಇ ರಂಡಿ ಮಕ್ಕಳಿಗೆ ಸೊಕ್ಕ ಬಹಳ ಬಂದಿದೆ ಮನೆ ಕಟ್ಟುವುದು ಇವರಿಗೆ ಹೊಟ್ಟಿಕಿಚ್ಚು ಬಿದ್ದಿದೆ , ಇನ್ನೊಮ್ಮ ಮನೆ ವಿಷಯಕ್ಕೆ ಬಂದರೆ ನಿಮ್ಮ ಜೀವ ಸಹಿತ ಬೀಡುವುದಿಲ್ಲ”, so as to cause

alarm in their mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
