C.C.NO.4765/2024

State by Nimbarga P.S. V/s Gurushantappa & Another.

CHARGE

I, Smt. Suman Chittargi B.Com., LL.M., PRL. Civil Judge & JMFC, Aland, do hereby charge you:

1. Gurushantappa S/o Suryakant Biradar,
Aged: 38 years, Occ; Private Teacher Work,
2. Shrishail S/o Suryakant Biradar,
Aged: 36 years, Occ: Private Work,

Both are R/o. Madiyal Village, Tq: Aland.

.....as under:

That, you on accused No.1 and 2 on 11.05.2024 at about 8.30 A.M. at Madiyal village in the land bearing Sy.No.332/2, within the jurisdiction of Nimbarga Police Station, you accused No.1 and 2 committed criminal trespass by entering into the above said land of CW1 and thereby you have committed an offence punishable U/Sec.447 R/w Sec.34 of Indian Penal Code and within my cognizance.

That, on the above said date, time and place during the course of same transaction, you accused No.1 and 2 infurtherance

of common intention, when CW1 was questioned the same to accused No.1, at that time, you accused No.1 intentionally insulted him by abusing in filthy words such as "ಏ ರಂಡಿ ಮಗನೆ ನನಗೆ ಕೇಳಲು ಬರುತ್ತಿಯಾ" provoked the C.W.1, intending that such provocation would cause him to break the public peace and thereby you have committed an offence punishable under Section 504 R/w 34 of IPC and within my cognizance.

That, on the above said date, time and place during the course of same transaction, you accused No.1 and 2 infurtherance of common intention, you have wrongfully restrained CW1 movement with an intention to commit certain offences and thereby committed an offence punishable under Section 341 Read with 34 of IPC and within my cognizance.

That, on the above said date, time and place during the course of same transaction, you accused No.1 and 2 infurtherance of common intention, you accused No.1 voluntarily assaulted with stone on his forehead and sustained bleeding injury, at that time, CW4 came to pacify the quarrel, accused No.2 voluntarily assaulted CW4 with knife on his left hand near elbow and sustained bleeding injury by using said objects as weapons of offences and thereby committed an offence punishable under Section 324 R/w 34 of IPC and within my cognizance.

That, on the above said date, time and place during the course of same transaction, you accused No.1 and 2 infurtherance of your common intention, you accused No.1 voluntarily assaulted CW1 with hands on his back and caused internal injury and thereby committed an offence punishable under Section 323 R/w 34 of IPC and within my cognizance.

That, on the above said date, time and place during the course of same transaction, you accused No.1 an 2 infurtherance of your common intention and threatened him and the C.W.1 and CW4 so as to cause alarm in their mind by committing an act of criminal intimidation and thereby committed an offence punishable under Section 506 R/w 34 of IPC and within my cognizance.

And I hereby direct that, you be tried for the said offences.
