C H A R G E

I, **YALLAPPA KALLAPUR**, C/c. Addl. Civil Judge & JMFC Aland, do
hereby charge you,

ACCUSED:

1. Smt. Mallamma @ Indubai W/o. Suryakanth Parit,
Aged: 55 yrs. Occ: Agri.& Household,
R/o. Sarasamba Village, Tq: Aland.
2. Suryakanth S/o. Kalyani Parit,
Aged: 61 yrs. Occ: Agriculture,
R/o. Sarasamba Village, Tq: Aland.
3. Govind S/o. Suryakanth Parit,
Aged: 29 yrs. Occ: Private Work,
R/o. Sarasamba Village, Tq: Aland.

As follows:

Firstly, that on 30.12.2019 at 4:00 p.m. on the border of Allapur(S) in land Sy.No.12/2 at Sarasamba Village, within the limits of Madan Hipparga Police Station, you, the accused No.1 to 3 picked up quarrel with previous enmity of CW1, have wrongfully restrained CW1 from proceeding in any direction in which CW1 has right to proceed and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Secondly, that on the above said date, time and place, in furtherance of above offence and in prosecution of common intention, you, the accused No.1 intentionally insulted CW1 by abusing her in filthy language stating that “ಏ ರಂಡಿ ಬೋಸಡಿ ನಮ್ಮ ಹೋಲದಾಗ ಬೋರವೇಲ್ ಹಾಕಿವಿ ಸುಮ್ಮಸುಮ್ಮನೆ ವಾದ ಮಾಡತಿ” and you, the accused No.2 and 3 abused her in language stating that “ರಂಡಿದ್ದು ಬಹಳ ಆಗ್ಲಾದ” and gave provocation to CW1 intending or knowing it to be likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Thirdly, that on the above said date, time and place, in furtherance of above offence and in prosecution of common intention, you, the accused No.1 assaulted CW1 on her cheek and back and knocked her down and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Finally, that on the above said date, time and place, in furtherance of above offence and in prosecution of common intention, you, the accused No.1 knocked her down, due to which by poking the bangles, she caused hurt to CW1 and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

And I hereby direct that you be tried by this Court on the said

charge.
