SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that, on 09.08.2022 at 10:00 a.m. NSL Sugar Factory at Bhusnoor, within the limits of Nimbarga police station, the brother of CW1 by name Ritikaraya S/o. Rajuraya was working along with CW1, CW2, CW3, CW6 and CW7 moving the tins near the boiler on the 3rd floor through Chain Pulli on that time the said Ritikaraya high nerves were caught hold and he was fell-down and CW1, CW2, CW3, CW6 and CW7 have given the first aid at the said sugar factory. On 10.08.2022 at 9:30 a.m. when they came for work and they have requested you

accused No.1 to 3 to give them safety measures for their lives safety, but you accused No.1 to 3 have not given the safety measures to them. On 13.08.2022 at 8:00 a.m. when the CW1, CW2, CW3, CW6 and CW7 were working in the said factory, the said Ritikaraya was suffering the said thigh nerves pain, at that time, the CW1, CW2, CW3, CW6, CW7 along with accused No.1 and 2 taken the said Ritikaraya through the NSL Ambulance to the Dekkan Care Hospital at Kalaburagi at 10:30 a.m. when the Ritikaraya was taking the treatment in the said hospital, the doctors have advised them to take for further treatment to the District Government Hospital, Kalaburagi he was succumbed on the way to the hospital and thereby caused the death of the deceased by you, due to not providing the safety measure and negligent act not amounting to culpable homicide and thereby you have committed an offence punishable U/Sec.304-A of Indian Penal Code, within the cognizance of this court.
