*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do  
hereby charge you,*

**ACCUSED:**

1. Siddaram S/o. Devarao Patil,  
Aged: 62 years, Occ: Agriculture,
2. Sudhakar S/o. Siddaram Patil,  
Aged: 28 years, Occ: Employee,
3. Vimalabai W/o. Late. Amrutrao Patil,  
Aged: 53 years, Occ: Household and Agriculture,
4. Mallamma W/o. Shivanand Patil,  
Aged: 47 years, Occ: Household and Agriculture,
5. Mallikarjun @ Mallinath S/o. Shivanand Patil,  
Aged: 27 years, Occ: Agriculture,
6. Shivanand S/o. Devarao Patil,  
Aged: 64 years, Occ: Agriculture,
7. Yashwant S/o. Late Amruthrao Patil,  
Aged: 30 years, Occ: Coolie,

Above all are R/o. Madiyal village, Tq: Aland.

As follows;

Firstly, that on 09.02.2022 at 12.30 p.m. on a public place near the Gram Panchayat of Madiya village, within the limits of Nimbarga Police Station, when CW1 and CW6 were sitting on the said place, you accused No.1 to 7 came there formed an unlawful assembly and in prosecution of common object of the said assembly, namely, to commit rioting, to cause hurt, to intentionally insult and to criminally intimidated and thereby you have committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 7 being members of an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence and thereby you have committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 7 being members of an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence you the accused were armed with club and thereby you have committed an offence punishable U/Sec.148 R/w Sec.149 of Indian Penal Code, within my cognizance.

Fourthly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly in prosecution of common object, you accused No.1 and 2

intentionally insulted CW2 by abusing him in filthy language like “ ಏ ರಂಡಿ ಮಗನೆ ನಮಗೆ ಆಸ್ತಿ ಹಂಚಿಕೊಡು ಸೂಳೆ ಮಗನೆ”, you accused No.4 and 5 intentionally insulted CW5 by abusing her in filthy language like “ರಂಡಿ” thereby gave provocation to them and also intentionally insulted intending or knowing it to be likely that such provocation will cause CW2 and CW5 to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code, within my cognizance.

Fifthly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly, in prosecution of common object, you accused No.3 to 7 voluntarily caused hurt to CW2 on his stomach and kicked him and thereby you have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code, within my cognizance.

Sixthly, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly, in prosecution of common object, when CW5 came to pacify the quarrel, you accused No.4 and 5 wrongfully restrained the movement of CW5 from proceeding further with an intention to commit certain offences and thereby you have committed an offence punishable U/Sec.341 R/w Sec.149 of Indian Penal Code, within my cognizance

Finally, that on the above said date, time and place, you accused No.1 to 7 were members of an unlawful assembly, in

prosecution of common object, you accused No.2 voluntarily caused hurt to CW2 on his head with club and caused internal pain, if which is used as weapon of offence is likely cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.149 of Indian Penal Code, within my cognizance

And I hereby direct that you be tried on the said charge.
