C H A R G E

*I, YALLAPPA KALLAPUR, Prl. Civil Judge & JMFC Aland, do
hereby charge you,*

ACCUSED:

1. Yallappa & Bhimsha Dhotre,
Aged: 54 years, Occ: Coolie,
 2. Hanamawwa W/o. Yallappa Dhotre,
Aged: 47 years, Occ: Coolie,
- Above all are R/o. Aya Jungle, Aland.

As follows;

Firstly, that on 15.02.2024 at 8:00 a.m. at Aya Jungle, Aland, in front of the house of CW1, on public road, within the limits of Aland Police Station, when CW1 was standing on road, you accused No.1 and 2 in furtherance of common intention, you accused No.2 intentionally insulted CW1 by abusing her in filthy language as “ಏ ರಂಡಿ ಪದೆ ಪದೆ ಹಣ ಕೇಳಲು ಬರುತ್ತಿ” thereby gave provocation to CW1 intending or knowing it likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you

accused No.2 slapped CW1 on her cheek and you accused No.1 voluntarily caused hurt to CW1 and also knocked her and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Thirdly, that on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No1 pulled hands of CW1, a woman intending to outrage her modesty or knowing fully well that the intended act is likely to outrage the modesty of the said woman and thereby you have committed an offence punishable U/Sec.354 R/w Sec.34 of Indian Penal Code, within my cognizance.

Fourthly, that on above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.1 and 2 voluntarily caused hurt to CW1 on her left hand middle ring & little finger with club and caused grievous injuries, which it used as a weapon of offence, is likely to cause death and thereby you have committed an offence punishable U/Sec.325 R/w Sec.34 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.1 and 2 criminally intimidated CW1 by threatening to take away her life stated that “ ನಿನ್ನ ಹಿಂದೆ ಯಾರು ಇಲ್ಲಾ ನಿನ್ನ ಹಣ ಕೊಡುವುದಿಲ್ಲ ಇನ್ನೊಮ್ಮೆ ಹಣ ಕೇಳಲು ಬಂದರದ ನಿನಗೆ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ”, so as to cause alarm in her mind and thereby you have committed an offence punishable

U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
