C H A R G E

I, Smt. Suman Chittargi B.Com., LL.M., Prl. Civil Judge & JMFC, Aland, do hereby charge you:

ACCUSED:

1. Vinod S/o Malappa Soravase,
Age: 26 years, Occ: Private Work,
 2. Malappa S/o. Sharanappa Soravase,
Age: 54 years, Occ: Private Work,
 3. Bangarewwa W/o Malappa Soravase,
Age: 47 years, Occ: Household,
 4. Vishal S/o Malappa Soravase,
Age: 23 years, Occ: Agriculture,
 5. Laxman S/o. Sharanappa Soravase,
Age: 51 years, Occ: Agriculture,
 6. Sanjukumar S/o Laxman Soravase,
Age: 20 years, Occ: Agriculture
- Above all are R/o. Mataki Village, Tq: Aland.

As follows:

That you accused No.1 to 6 between on 02.02.2024 at 11:00 a.m. to 03.02.2024 at 7:30 a.m. at Mataki village, in front of the house of CW1, within the jurisdiction of Aland Police Station, when the CW1, 4 and 5 were in the house, you accused No.1 to 6 having previous enmity and based on the previous incident, formed yourself into an unlawful assembly with common object to commit rioting and to intentionally insult CW1, 4 and 5 and thereby you have committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 6 in prosecution of common object formed yourself into an unlawful assembly and assembled together with an intention to commit certain offences and committed an act of rioting and thereby you have committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 6 in prosecution of common object formed yourself into an unlawful assembly and assembled together with an intention to commit certain offences and committed an act of rioting at that time, you accused persons armed with deadly weapons such as (handle of axe, club and one stone) and thereby you have committed an offence punishable U/Sec.148 R/w Sec.149 of Indian Penal Code, within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 6 in prosecution of common object, picked up quarrel with the pervious enmity of CW1, you accused No.5 intentionally insulted CW1 by abused him in filthy language stating that “ ನಿಮಗೆ ನಮ್ಮ ಮನೆಯ ಮುಂದೆ ನಾಲಿ ನೀರು ಬಿಡಬೇಡ ಅಂತಾ ಹೇಳುತ್ತಿದ್ದರೂ ಕೇಳುತ್ತಿಲ್ಲ ನಾನು ಬೆಂಗಳೂರಿನಿಂದ ಅದಕ್ಕೆ

ಬಂದಿದ್ದು” provoked him intending that such provocation would cause him to break the public peace and thereby you have committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code and within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 6 in prosecution of common object, picked up quarrel with the previous enmity of CW1, CW4 came to pacified the quarrel at that time, you accuse No.5 kicked on her waist and you accused No.3 knocked down the CW5 on the ground and thereby you have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code and within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 6 in prosecution of common object, picked up quarrel with previous enmity of CW1, you accused No.6 assaulted CW1 with a stone on his head and chin and caused internal injury, CW5 came to pacify the quarrel, you accused No.1 assaulted CW5 with a club on her left shoulder and caused internal injury, you accused No.2 assaulted CW1 with a club on his forearm, you accused No.4 bitten the CW1 on his left hand ring finger, you accused No.6 assaulted CW5 with a stone on her head and caused internal injury and thereby you have committed an offence punishable U/Sec.324 R/w Sec.149 of Indian Penal Code and within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 6 in prosecution of common object, picked up quarrel with previous enmity of CW1, you accused No.1 assaulted CW1 with an axe on his head and caused grievous injury and thereby you have

committed an offence punishable U/Sec.326 R/w Sec.149 of Indian Penal Code and within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 6 in prosecution of common object, picked up quarrel with previous enmity of CW1, you accused No.4 came to the spot and criminally intimidated CW1 and CW5 by threatening to take away their lives as “ ಈ ರಂಡಿ ಮಕ್ಕಳದು ಬಹಳ ಆಗ್ಯಾದ ನಾಲಿ ನೀರು ನಮ್ಮ ಮನಿ ಮುಂದೆ ಬಿಡಬೇಡ ಅಂತಾ ಹೇಳಿದರೂ ಕೇಳುತ್ತಿಲ್ಲ ಇವರಿಗೆ ಒಂದು ಗತಿ ಕಾಣಿಸೋಣ”, so as to cause alarm in their mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code and within the cognizance of this court.

And I hereby direct that you be tried on the said charge by this Court.
