I, Smt. Suman Chittargi B.Com., LL.M., Prl. Civil Judge & JMFC, Aland, do hereby charge you:

ACCUSED:

1. Mahesh S/o Revansidda Dhabadhabe,
Aged: 38 years, Occ: Coolie Work,
 2. Siddamma W/o Mahesh Dhabadhabe,
Aged: 32 years, Occ: Household,
 3. Sangamma W/o Revansidda Dhabadhabe,,
Aged: 60 years, Occ: Household,
 4. Sarubai W/o Nagesh Kasar,
Aged: 45 years, Occ: Household,
 5. Padma W/o Vishwanath Pawane,
Aged: 45 years, Occ: Household,
- Above all are R/o. Sultanpur Galli Aland, Tq: Aland.

As follows:

That you accused No.1 to 5 on 18.06.2025 at about 08:00 A.M. at Sultanpur Galli Aland, in the house No.1-4-39/1, which comes

within the jurisdiction of Aland Police Station, when CW1 was making construction of brick wall through CW-6, at that time you accused No.1 to 5 picked up quarrel with CW-1 having previous enmity and you all accused persons formed yourself into an unlawful assembly assembled together with an intention to commit certain offences and thereby you have committed an offence punishable U/Sec.189(2) R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 5 in prosecution of your common object, you all accused persons formed yourself into an unlawful assembly assembled together with an intention to commit certain offences and thereby committed an act of rioting with deadly weapons and thereby you have committed an offence punishable U/Sec.191(2) R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 5 in prosecution of your common object, you all accused persons picked up quarrel with the informant, entered into the house premises of the informant by committing an act of house trespass with an intention to commit certain offences and thereby you have committed an offence punishable U/Sec.329(4) R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 5 in prosecution of your common object, you all accused persons picked up quarrel with the informant, you accused No.3 and 4 pushed the CW-1 towards earth and caused internal injury to CW-1 and thereby you have committed an offence punishable

U/Sec.115(2) R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 5 in prosecution of your common object, you all accused persons picked up quarrel with the informant, you accused No.1 used the criminal force on CW-1, dragged her by holding her saree with an intention to outrage her modesty and thereby you have committed an offence punishable U/Sec.74 R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 5 in prosecution of your common object, you all accused persons picked up quarrel with the informant, and you accused No.1 caused wrongful loss by committing an act of mischief by demolishing the constructed the brick wall and thereby you have committed an offence punishable U/Sec.324(4) R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 5 in prosecution of your common object, you all accused persons picked up quarrel with the informant, you Accused No.1 abused to the CW-1 as " ಏ ಬೋಸಡಿ ಮಕ್ಕಳೇ ನೀವು ಯಾರಿಗೆ ಕೇಳಿ ಮನೆ ಗೋಡೆ ಕಟ್ಟುತ್ತಿದ್ದಿರಿ ರಂಡಿ ಮಕ್ಕಳೇ" and you accused No.2 abused to the CW-1 as " ರಂಡಿ ಬೋಸಡಿಗೆ ಮರ್ಯಾದೆ ಇಲ್ಲ, both have intentionally insulted and provoked her intending that such provocation would cause her to break the public peace and thereby you have committed an offence punishable U/Sec.352 R/w Sec.190 of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 5 in prosecution of your common object, you all accused

persons picked up quarrel with the informant and threatened her as " ನಿನ್ನ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ " with dire consequence so as to cause alarm in her mind by committing an act of criminal intimidation and thereby you have committed an offence punishable U/Sec.351(2) R/w Sec.190 of BNS, within the cognizance of this Court.

And I hereby direct that you be tried on the said charge by this Court.
