**C H A R G E**

**I, Smt. Suman Chittargi B.Com., LL.M.,** Prl. Civil Judge & JMFC, Aland, do hereby charge you:

**ACCUSED:**

1. Annarao S/o Bhimsha Nirmalkar,  
Aged: 63 years, Occ: Retired ASI,
2. Vilas @ Vilaskumar S/o Annaraya Nirmalkar,  
Aged: 35 years, Occ: Private work,
3. Vinod @ Vinodkumar S/o Annaraya Nirmalkar,  
Aged: 37 years, Occ: Private Work,
4. Sagar @ Vidyasagar S/o Annaraya Nirmalkar,  
Aged: 32 years, Occ: Private Work,
5. Savita W/o Vinodkumar Nirmalkar,  
Aged: 35 years, Occ: Household,
6. Pallavi @ Parvati W/o Vilaskumar Nirmalkar,  
Aged: 29 years, Occ: Household,
7. Chandrakala @ Chandawwa W/o Annaraya Nirmalkar,  
Aged: 62 years, Occ: Household,

As follows:

That you accused No.1 to 8 on 28.09.2023 at 10.00 a.m at Nimbarga Village, in front of the house of CW1, on open space, within the jurisdiction of Nimbarga Police Station, you accused No.1 to 8 formed yourself into an unlawful assembly with common object to commit rioting and to intentionally insult CW1 and CW4 and thereby you have committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code, within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 8 being members of an unlawful assembly, in prosecution of common object of the said assembly, committed an act of rioting with an intent to commit other offences and you have committed an offence of rioting armed with deadly weapon such as club and thereby you have committed an offence punishable U/Sec.147 and

148 R/w Sec.149 of Indian Penal Code, within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 8 in prosecution of your common object, you have wrongfully restrained the movement of CW1 and CW4 with an intention to commit certain offences and thereby you have committed an offence punishable U/Sec.341 R/w Sec.149 of Indian Penal Code and within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 8 in prosecution of your common object, you have intentionally insulted the CW1 and CW4 by abusing them in filthy words and you accused No.5 to 8 intentionally insulted the CW1 by abusing her words as " ನೀನು ಬಿಡಿಸಲು ಬರುತ್ತಿ ರಂಡಿ" provoked them intending that such provocation would cause them to break the public peace and thereby you have committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code and within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 8 in prosecution of your common object, you accused No.1 to 4 slapped CW4 on his cheek and you accused No.5 to 8 by pulling her hairs and also slapped CW1 on her cheek and thereby you

have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code and within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 8 in prosecution of your common object, you accused No.3 voluntarily caused hurt to CW4 with club on his back, right hand, forearm and waist, you accused No.2 voluntarily caused hurt to CW4 with club on his head, you accused No.4 voluntarily caused hurt to CW4 with club on his back and caused bleeding and internal injuries, by using said objects as weapons of offences and thereby committed an offence punishable under Section 324 R/w 149 of IPC and within the cognizance of this Court.

That on above said date, time and place, you accused No.1 to 8 in prosecution of your common object, you have criminally intimidated CW1 and CW4 by threatening to take away their lives stating that " ಇವತ್ತು ಉಳಿದಿರಿ ಇನ್ನೊಮ್ಮೆ ನಮ್ಮ ತಂಟೆಗೆ ಬಂದರೆ ಮತ್ತು ಸದರಿ ಜಾಗದಲ್ಲಿ ಹಾಕಿದ ಕಲು ಮತ್ತು ಕಟ್ಟಿಗೆ ತೆಗೆಯದಿದ್ದರೆ ನಿಮಗೆ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ ಖಲಾಸ ಮಾಡಿಯೆ ಬಿಡುತ್ತೇವೆ", so as to cause alarm in their mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code and within the cognizance of this court.

And I hereby direct that you be tried on the said charge by this Court.
