C H A R G E

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Muttawwa W/o. Chandrakanth Ghodake,
Aged: 45 yrs. Occ: Agri. & Household,
2. Chandrakanth S/o. Malappa Ghodake.
Aged: 51 yrs. Occ: Agriculture,

Above both are R/o. Savaleshwar, Tq: Aland.

As follows:

Firstly, that on 18.09.2021 at 7:00 p.m. at Savaleshwar Village, in the house yard of CW1, within the limits of Aland Police Station, when CW1 was walking on there, you accused No.1 and 2 picked up quarrel with previous dispute, you accused No.1 wrongfully restrained CW1 the movement of CW1 from proceeding further and to commit certain offence and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code and within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.1 intentionally insulted CW1 by abusing her in filthy language stating that “ಏ ರಂಡಿ ನೀನು ಕಟ್ಟುವ ಮನೆಯ ಗೋಡೆಯಲ್ಲಿ ನನಗೂ ಸಹ ಪಾಲು ಇದ್ದು, ಸದರಿ ಜಾಗದಲ್ಲಿ ನೀನು ಯಾಕೆ ಛಿತ್ತು ಹಾಕಬೇಕು ಅಂತಾ ಹೇಳುತ್ತಿದ್ದಿ”, you accused No.2 intentionally insulted CW1 by abusing her in filthy language stating that “ಃ ರಂಡಿ ಮಕ್ಕಳದು ಬಹಳ” and gave provocation to CW1 intending or knowing it to be likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Thirdly that, on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.1 voluntarily caused hurt to CW1 on her cheek and back with hands and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Finally, that on above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.3 criminally intimidated CW1 by threatening to take away her life “ಇವರಿಗೆ ಬಹಳ ಸೊಕ್ಕು ಬಂದಿದೆ ಇವರಿ ಒಂದು ಕೈ ನೊಡಿಯೇ ಬೀಡಬೇಕು ಎಲ್ಲಿಗ್ಯಾಕ ಹತ್ತಾಲೇಕ”, so as to cause alarm in her mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

And I hereby direct that you be tried by this Court on the said charge.
