ACCUSED:

As follows;

Firstly, that on 30.04.2018 at 9:15 p.m. at Sangolgi[C] Village, in front of the house of accused No.1, within the limits of Narona Police Station, when CW1 to 4 went to the house of accused No.1 and requested accused No.1 not to object to remove mud from the land, you, the accused No.1 to 14 then formed an unlawful assembly and in prosecution of common object of the said assembly, to commit rioting, to cause hurt, to intentionally insult and to criminally intimidate and thereby committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code, within the cognizance of this court.

Secondly, that on the above said date, time and place, in furtherance of above offence, you, the accused Nos.1 to 14 being

members of an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence and thereby committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code, within the cognizance of this Court.

Thirdly, that on the above said date, time and place, in furtherance of above offence, you, the accused Nos.1 to 14 being members of an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence you the accused were armed with deadly weapons and thereby committed an offence punishable U/Sec.148 R/w Sec.149 of Indian Penal Code, within the cognizance of this court.

Fourthly, that on above said date, time and place, in furtherance of above offence, you the accused No.1 to 14 being members of an unlawful assembly and in prosecution of your common object, you the accused No.1 to 14 intentionally insulted CW1 by abusing him in filthy language stating that "ಎ ಬೋಸಡಿ ಮಗನೆ ನೀನು ನಮ್ಮ ಹೊಲದಾಗಿನಿಂದ ಮಣ್ಣು ಕೆದರಿ ನಮಗೆ ಕೇಳಕ್ಕೆ ಬರತ್ತಿಯಾ" and thus insulted CW1 intending or knowing it to be likely that such provocation will cause him to break the public peace or to commit any other offence and thereby committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code, within the cognizance of this court.

Fifthly, that on the above said date, time and place, in furtherance of above offence, you accused Nos.1 to 14 being

members of an unlawful assembly, in prosecution of common object, you the accused Nos.1, 2, 4 to 14 knocked him down on the ground, surrounded him, assaulted with hands and kicked him and caused simple injury and thereby committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code, within the cognizance of this court.

Sixthly, that on the above said date, time and place, in furtherance of above offence and you the accused Nos.1 to 14 being members of an unlawful assembly, in prosecution of common object, you the accused No.3 assaulted CW1 with a stone on his left side of the forehead and caused bleeding injury, by deadly weapon and thereby committed an offence punishable U/Sec.324 R/w Sec.149 of Indian Penal Code, within the cognizance of this Court.

Finally, that on the above said date, time and place, in furtherance of above offence and you accused Nos.1 to 14 being members of an unlawful assembly, in prosecution of common object, when CW2 to 4 tried to pacify the quarrel at that time, you the accused No.1 to 14 threatened CW2 to 4 stating that you will take away their life “ ನಿವೇನಾದರು ಈ ಜಗಳ ಬಿಡಿಸಿದಲ್ಲಿ ನಿಮಗೆ ಖಲಾಸ ಮಾಡುತ್ತೇವೆ” and thereby committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code, within the cognizance of this Court.

And I hereby direct that you be tried on the said charge.
