CHARGE

I, **YALLAPPA KALLAPUR**, *Prl. Civil Judge & JMFC Aland*, do hereby charge you,

ACCUSED:

1. Khadir @ Mahammad Khadir S/o. Mulak Sab Nimbargi,
Aged: 27 years, Occ: Working in Finance,
 2. Sahera Banu @ Banu Begum W/o. Mahammad Khadir,
Aged: 25 years, Occ: Housewife,
 3. Akbar S/o. Khasim Sab Gundagurti,
Aged: 72 years, Occ: Coolie,
 4. Wajirabi W/o. Akbar Gundagurti,
Aged: 65 years, Occ: Housewife,
- Above both are R/o. Khanapur village, Taluka Aland.

As follows;

Firstly, that on 27.09.2022 at 10:30 a.m. at Khanapur village, within the limits of Aland Police Station, when CW1 was went near her house for bringing the sticks, you accused No.1 to 4 in furtherance of common intention, you accused No.1 intentionally insulted CW1 by abusing her in filthy language as “ಏ ತೇರಿ ಮಾಕಾ

ಭೋಸಡಾ” and thereby gave provocation to CW4 intending or knowing it likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.3 and 4 wrongfully restrained the movement of CW1 from proceeding further and to commit certain offence and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code, within my cognizance.

Thirdly, that on above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.1 voluntarily caused hurt to CW1 on her head with stone and caused bleeding injury, you accused No.2 voluntarily caused hurt to CW1 on her left hand, shoulder and head with stone and caused internal injury, which it used as a weapon of offence, is likely to cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.3 and 4 voluntarily caused hurt to CW1, when CW4 came to pacify the quarrel, you accused No.2 and 4 voluntarily caused hurt to CW4 and thereby you have committed an offence punishable

U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
