C H A R G E

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Jagappa @ Jagannath S/o. Mahantappa Gundagurti,
Aged: 27 years, Occ: Coolie,
2. Mallappa @ Mallikarjun S/o. Mahantappa Gundagurti,
Aged: 37 years, Occ: Coolie,
3. Nagappa S/o. Ganapati Gundagurti,
Aged: 30 years, Occ: Agriculture,

Above all are R/o. Battaraga village, Tq: Aland.

As follows;

Firstly, that on 19.03.2020 at 10:30 p.m. near the bridge at Bhattaraga village, within the limits of Nimbarga Police Station, CW1 was coming on a motor cycle from Dhangapur village to Bhattaraga village, on the above said place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 stopped the motorcycle of CW1 and wrongfully restrained the movement of CW1 from proceeding further and to commit certain offence and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 intentionally insulted CW1 by abusing him in filthy language stated that “ಏ ರಂಡಿ ಮಗನ ಬೈಕ ನಿಲ್ಲಿಸು, ನನ್ನ ಮನೆಯ ಮಾಳಿಗೆ ಮ್ಯಾಲ ಯಾಕ ಏರಿದಿ ನಿನ್ನೊನ”, you accused No.1 and 2 intentionally insulted CW1 by abusing him in filthy language stated that “ಏ ರಂಡಿ ಮಗನ ನಮ್ಮ ಮನಿ ಮ್ಯಾಲ ಏನ ಇಟ್ಟಿದಿ ರಂಡಿ ಮಗನ” and thereby gave provocation to C.W.1 intending or knowing it likely that such provocation will cause C.W.1 to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 voluntarily caused hurt to CW1 on his cheek with hand, you accused No.1 and 2 voluntarily caused hurt to CW1 on his left hand with hand and caused internal injury and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Fourthly, that on above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.2 voluntarily caused hurt to CW1 on his back with with stick and clotted his blood, you accused No.3 voluntarily caused hurt to CW1 on his back with belt, if which are used as a weapons of offence is likely to cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, CW4 and CW5 were pacified the quarrel, you accused No.1 to 3 criminally intimidated CW1 by threatening to take away his life stated that “ಇನ್ನೊಮ್ಮೆ ನೋಡಕೋತಿನಿ”, so as to cause alarm in his mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
