C H A R G E

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Gunnakabai @ Hunakabai W/o. Laxman Pawar,
Aged: 60 years, Occ: Housewife,
2. Laxman S/o. Tekku Nayak Pawar,
Aged: 65 years, Occ: Agriculture,
3. Pawan S/o. Laxman Pawar,
Aged: 34 years, Occ: Agriculture,
4. Pooja W/o. Pawan Pawar,
Aged: 21 years, Occ: Housewife,
5. Mohan S/o. Gopichand Pawar,
Aged: 42 years, Occ: Agriculture,

Above all are R/o. Honnalli Tanda, Tq: Aland.

As follows;

Firstly, that on 24.05.2022 at 4:00 p.m. at Honnalli Tanda, within the limits of Aland Police Station, you accused No.1 to 5 came by forming an unlawful assembly and in prosecution of common object of the said assembly, namely, to commit rioting, to cause hurt, to intentionally insult and to criminally intimidated

and thereby you have committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 5 being members of an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence and thereby you have committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 5 were members of an unlawful assembly, in prosecution of common object, you accused No.1 to 4 intentionally insulted CW1 by abusing her in filthy language as “ರಂಡಿ ನಮಗೆ ರೇಷನ್ ಕೇಳಲು ಬರುತ್ತಿ ಸೂಳಿ” and thereby gave provocation her and also intentionally insulted intending or knowing it to be likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code, within my cognizance.

Fourthly, that on the above said date, time and place, you accused No.1 to 5 were members of an unlawful assembly in prosecution of common object, you accused No.1, 3 and 4 wrongfully restrained the movement of CW1 from proceeding further with an intention to commit certain offenses and thereby you have committed an offense punishable U/Sec.341 R/w Sec.149 of Indian Penal Code, within my cognizance.

Fifthly, that on the above said date, time and place, you accused No.1 to 5 were members of an unlawful assembly, in prosecution of common object, you accused No.3 voluntarily caused hurt to CW1 on her back with hand and caused internal pain and thereby you have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code, within my cognizance,

Sixthly, that on the above said date, time and place, you accused No.1 to 5 were members of an unlawful assembly, in prosecution of common object, you accused No.2 pulled the hairs of CW1 and you accused No.1, 3 and 4 have pulled the hands of CW1 and used criminal force to CW1 a woman with an intention to outrage her modesty and thereby you have committed an offence punishable U/Sec.354 R/w Sec.149 of Indian Penal Code, within my cognizance.

Seventhly, that on the above said date, time and place, you accused No.1 to 5 were members of an unlawful assembly, in prosecution of common object, when CW4 and CW5 came to pacify the quarrel, you accused No.3 voluntarily caused hurt to CW4 on his head, chest and back with club and caused internal pain, if which is used as a weapon of offence is likely cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.149 of Indian Penal Code, within my cognizance

Finally, that on the above said date, time and place, you accused No.1 to 5 were members of an unlawful assembly in prosecution of common object, you accused No.5 criminally

intimidated by threatening CW1 life as “ಪದೆ ಪದೆ ಜಗಳ ಮಾಡುತ್ತಾಳೆ ಇವಳಿಗೆ ಬಂದೂಕಿನಿಂದ ಹೊಡೆಯಬೇಕು” so as to cause alarm in her mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code, within my cognizance.

And I hereby direct that you be tried on the said charge.
