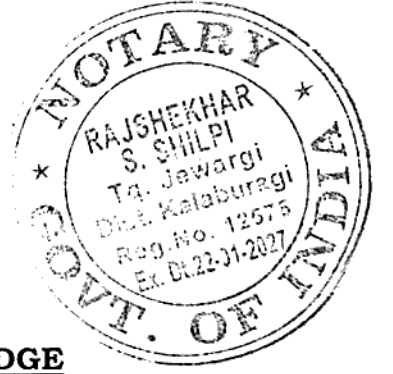

1. That, I am the petitioner in the above case, hence knows the facts of the case.

That, on 25-04-2024 myself and my nephew Abhishek were proceeding to Shahabad on a motorcycle bearing Reg.No.KA-32/HE-1846, I am pillion rider over the said motorcycle and said Abhishek was riding the said motorcycle slowly and cautiously at about 03-00 pm when we were in front of Reliance Petrol pump Jewargi Town, on Jewargi-Kalaburagi NH Road, at the point of time one Bolero Jeep bearing Reg No.KA-33/N-0479 came from back side driven by its driver in high speed, in rash and negligent manner, endangering to the road users and dashed to the said motorcycle as a result of the heavy impact I have sustained communitted fracture of the left Neck of Femur bone and other parts of the body, whereafter immediately I was shifted to United Hospital Kalaburagi for treatment in the said Bolero Jeep, wherein I was treated as an inpatient from 25-04-2024 to 15-05-2024, after discharge from the said hospital I am still under follow-up treatment and I have spent Rs.3,50,000/- towards my medical expenses.

3. Before the accident, I was hale and healthy, aged about 43 years, and earning Rs.18,000/- per month by doing homemaker

work, due to accidental fracture injuries over the left neck of the femur bone I was unable to do household work, as did earlier to the accident, and due to which I am facing the hardship while doing day to day normal work, monthly period, and enjoyment of marital life, I am only earning member of the family and spending my entire income towards the welfare of my family now my life and my family became miserable, I have sustained 100% functional physical disability and I am needs another Rs.1,50,000/- for my future medical expenses.

4. That, the said accident occurred due to rash and negligent driving of a Bolero Jeep bearing Reg.No.KA-33/N-0479 by its driver.

5. That, Respondent No.1 is the owner and Respondent No.2 is the insurer of the Bolero Jeep bearing Reg.No.KA-33/N-0479, its policy is in force on the date of the accident and also the risk of the third party is covered under the policy issued by the respondent No.2 company, therefore the respondents are jointly and severally liable to pay the compensation to me for an act done by the driver of the offending vehicle, as claimed by me.

6. That, the documents filed by me may kindly be marked as exhibits.

Therefore, it is most humbly prayed before the Hon'ble Court may please award the compensation of Rs.19,83,400/- to me holding that the respondents are jointly and severally liable to pay the compensation to me with interest and cost, in the interest of justice and equity.
