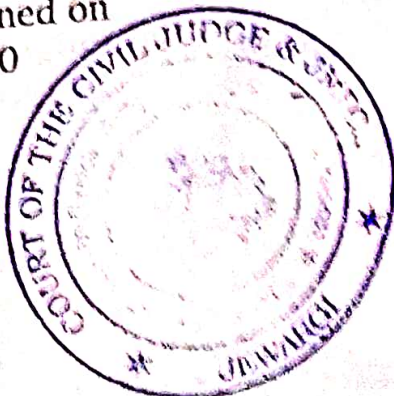

West : open Space of guranna Pujari Ryavanoor

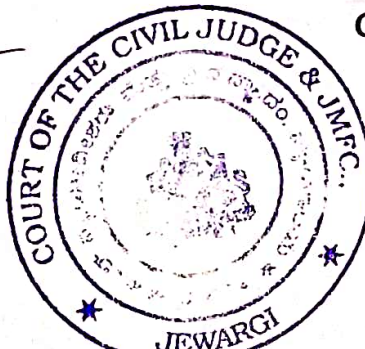
North : open Space of Malkappa Pujari
