I, **Sri. Sagar Gurugouda Patil, B.A.,LL.B.** (Spl), Senior Civil Judge & J.M.F.C., Sedam, do hereby charge you:

1. Krishna S/o Devaji Kambar, Age: 35 years, Occ: Agril, R/o Khanderayanapalli, Tq: Sedam.
2. Maipal S/o Nagappa Nagari, Age: 30 years, Occ: Agril, R/o Khanderayanpalli, Tq: Sedam.
3. Mallappa S/o Kashappa, Age: 60 years, Occ: Private Work, R/o Khanderayanpalli, Tq: Sedam.
4. Mukundraj S/o Channareddy Naikodi, Age: 33 years, Occ: Agril, R/o Khanderayanapalli, Tq: Sedam.
5. Narasimhlu S/o Hanamayya Kalal, Age: 62 years, Occ: Coolie, R/o Khanderayanpalli, Tq: Sedam.
6. Ramlu S/o Buggappa Pujari, Age: 40 years, Occ: Agriculture, R/o Khanderayanpalli, Tq: Sedam.

as follows.....

1. It is alleged that, on 29-06-2021 at about 11-30 a.m. at Khanderayanapalli village, within the jurisdiction of Mudhol Police station, you accused 1 to 6 formed into an unlawful assembly and in furtherance of common object of such assembly picked up quarrel

with CW.2 by stating that the CW.2 had filed objection in the Panchayat for forming CC road and pipeline near your house and committed the offence of rioting by holding deadly weapons like sticks and stones in your hands and thereby you have committed an offence punishable under sections 143, 147 and 148 R/w Sec.149 of Indian Penal Code within my cognizance.

2. That, on the above said date, time and place you accused 1 to 6 formed into unlawful assembly and in furtherance of common object of such assembly and you accused voluntarily caused hurt to CW.2 by assaulting with hands and thereby you have committed an offence punishable U/s.323 R/w Sec.149 of Indian Penal Code and within my cognizance.

3. That, on the above said date, time and place you accused 1 to 6 formed into unlawful assembly and in furtherance of common object of such assembly and you accused No.1 and 2 assaulted CW.2 with stick, you accused No.3 assaulted CW.3 and 4 with stone on their head, forehead and all over bodies to them and caused bleeding injuries to them, you accused No.4 assaulted CW.5 with stone on his body, you accused No.5 assaulted CW.6 with stone on his body and they caused bleeding injuries to them and thereby you have committed an offence punishable U/s.324 R/w Sec.149 of Indian Penal Code and within my cognizance.

4. That, on the above said date, time and place you accused 1 to 6 formed into unlawful assembly and in furtherance of common object of such assembly picked up quarrel with CW.2 and abused CW.1 to 6 in filthy language as "Le Bhosadi Makkale, Randi Makkalya" knowing it to be likely that such provocation will cause them to break the public peace or to commit any other offences and thereby you committed an offence punishable under section 504 R/w Sec.149 of Indian Panel Code and within my cognizance.

5. That, on the above said date, time and place you accused 1 to 6 formed into unlawful assembly and in furtherance of common object of such assembly and you accused No.1 caught hold the hand of CW.1 and assault and used criminal force against CW.1 with intent to outrage her modesty and thereby you have committed an offence punishable U/s.354 R/w Sec.149 of Indian Penal Code and within my cognizance.

6. That, on the above said date, time and place you accused 1 to 6 formed into unlawful assembly and in furtherance of common object of such assembly and you accused persons had committed the act of criminal intimidation by threatening the life of CW.1 to 6 stating that if they question you, you will kill them and with dire consequences and thereby you have committed an offence punishable under section 506 R/w Sec.149 of Indian Penal Code and within my cognizance.

And I hereby direct that, you be tried on the above said charges.
