As follows:

That, on 28.09.2023 at about 22.55 hrs a received message through security control/SC from the train manager of train no.16584 (Latur-Yesvantapur) Exp. Regarding stone pelted on train No.16584 (Latur-Yesvantapur) express on the rear brake van No.NFR 145853 at KM No.36/14-16 near Sedam railway station, resulting a window glass broken of rear brake van. On receipt of information AIPF/SEM along with staff proceeded to the spot and observed upon enquiry detained one person and asked him about stone pelting incident to which he revealed that , while in the family problems, and was mentally disturbed he tress passed near the railway track at KM No.36/14-16 near sedam Railway station without any lawful authority by that you have committed the offence punishable U/sec. 147 of Railway Act.

Finally as mentioned above in the same place, date and time you the accused, tress passed near railway track at KM NO.36/14-16 near Sedam Railway station and by endangering the safety of

persons traveling in the train threw a stone pelleted on the train. Resulting which window glass broken, there by you have committed the offence punishable U/sec. 153 of Railway Act.

There by you committed an offence U/sec.147 and 153 of Railway Act and within my cognizance.

And I hereby direct that you be tried by me on the above said charge.
