COMMITTAL ORDER

The PSI of Sedam Police Station, has submitted charge sheet



against the accused No.1 and 2 for the offences punishable under section 115(2), 118(1), 109, 352, 351(2) R/w section 3(5) of Bharatiya Nyaya Sanhita-2023.

2. After the investigation is completed, the Police have filed charge sheet, thereafter this court has taken cognizance of the offence against the accused No.1 and 2 for the above said offence. Accused No.1 and 2 are on bail as per the order passed by Hon'ble IV Additional District And Sessions Judge Kalaburgi, Sitting at Sedam in Crl.Misc.No.1028/2025, dated 05.07.2025. The copies of the charge sheet and other papers were supplied to the accused as required under section 230 of Bharatiya Nyaya Sanhita-2023.

3. The offence alleged against the accused i.e. 109 of Bharatiya Nyaya Sanhita-2023 exclusively triable by Court of Sessions and the other offence alleged also liable to be tried by the Court of Sessions. Therefore, the case on hand has to be committed for trial by the Hon'ble Court of Sessions. Therefore it is just and necessary that the case on hand has to be committed to the Hon'ble Court of Sessions,



Kalaburagi. Hence, I proceed to pass the following:

ORDER

Acting under section 232 of Bharatiya Nyaya Sanhita-2023, the case against the accused No.1 and 2 committed to the Hon'ble Prl. District & Sessions Judge, Kalaburagi for trial.

Accused No.1 and 2 are directed to appear before the Hon'ble court of sessions soon after receipt of summons without fail. Further accused No.1 and 2 are directed to execute personal bond of Rs.50,000/- each along with one surety.

Office is directed to send all the records and material objects if any to the Sessions Court, Kalaburagi.

Office to intimate the same to Learned Public Prosecutor.
