Case taken up before Lok-Adalath.

The petitioner, respondent and their respective counsel are present before Lok-Adalath. Conciliation is held, perused the documents on record and satisfied. Matter is settled and both the parties have filed joint consent Memo. In view of the joint consent memo, we proceed to pass the following;

**: ORDER:**

The petition filed by the petitioner under section 13 (3) of Birth and Death Registration Act is hereby allowed.

The respondent is directed to enter the date of birth of petitioner by name **Bhagyashree D/o Tippanna** who was born on **17-10-2008 at R/o Konchur Village, Tq: Chittapur, Dist: Kalaburagi** in the relevant register maintained by the respondent and issue birth certificate to the petitioner subject to payment of prescribed fee.
