C H A R G E

I, Sri. Shivakumar Deshmukh, B.A.L, L.L.M, Civil Judge & JMFC Shahabad, do hereby charge you,

Age: 35 years, Occ: Coolie,
- 6) Smt. Sheelabai W/o Vijaya Rathod,
Age: 38 years, Occ: Cooliek

All are R/o: Devanategnoor village, Tq:Shahabad.

That, you accused No.1 to 6 on 30.07.2023 at about 08.45 A.M. at Devanategnoor village, infront of house of C.W.1 on road, within the jurisdiction of Shahabad Town P.S., in-connection

with B.C. amount, you accused persons formed an unlawful assembly and picked up quarrel with C.W.1 with an intention to commit certain offences and thereby committed an offence punishable under Section 143 Read with Section 149 of IPC, within my cognizance.

That, you accused No.1 to 5 on the above mentioned date time and place in prosecution of common object all accused formed an unlawful assembly and assembled together in order to commit certain offences and thereby committed an act of rioting and thereby committed an offence punishable under Section 147 Read with Section 149 of Indian Penal Code and within my cognizance.

That, you accused No.1 to 5 on the above mentioned date time and place in prosecution of common object all accused formed an unlawful assembly and assembled together in order to commit certain offences and wrongfully restrained the C.W.1 from further proceedings and thereby committed an offence punishable under Section 341 Read with Section 149 of Indian Penal Code and within my cognizance.

That, you accused persons on the above mentioned date, time and place, during the course of same transaction, formed an unlawful assembly and picked up quarrel with C.W.1 and abused her in a filthy language and provoked her intending that such provocation would cause her to break the public peace and thereby committed an offence punishable under section 504

Read with Section 149 of Indian Penal Code and within my cognizance.

That, you accused persons on the above mentioned date, time and place during the course of same transaction, formed an unlawful assembly and picked up quarrel with C.W.1 and you accused No2 dragged the hairs of C.W.1 and assaulted on her cheek with hands and caused internal injury and thereby committed an offence punishable under Section 323 Read with Section 149 of Indian Penal Code and within my cognizance.

That, you accused persons on the above mentioned date, time and place during the course of same transaction, formed an unlawful assembly and picked up quarrel with C.W.1 you accused intending to insult the modesty of CW.1 by using utter words and thereby committed an offence punishable under section 509 Read with Section 149 of Indian Penal Code and within my cognizance.

That, you accused persons on the above mentioned date, time and place, during the course of same transaction, formed an unlawful assembly and picked up quarrel with C.W.1 and gave life threat to them by committing an act of criminal intimidation by putting them in fear with dire consequences so as to cause alarm in their mind and thereby committed an offence punishable under section 506 Read with Section 149 of Indian Penal Code and within my cognizance.

And I hereby direct that, you be tried for the said offences.
