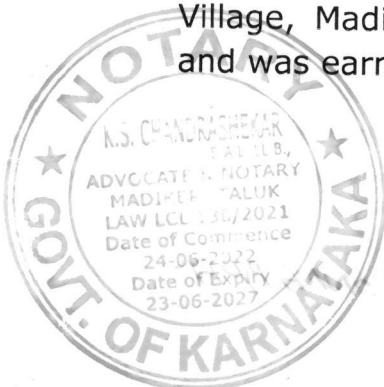

I, Ponnappa P.N, Aged 36 years, S/o. Sri. Nanaiah P.S, Hodavada Village and Post, Madikeri Taluk, Kodagu District do hereby solemnly affirm and state on oath as follows:-

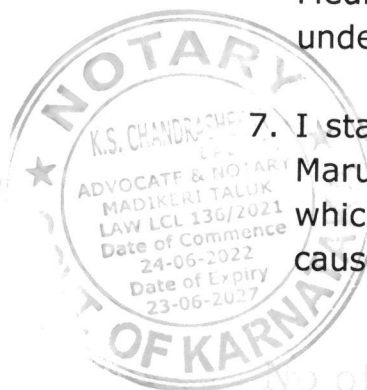
1. I state that I am the deponent of this affidavit I am well conversant with the facts that I am deposing hereunder.
2. I state that I am the Petitioner in the above Petition and I am swearing this affidavit in lieu of my examination in chief before this Hon'ble Court as required under Order XVIII Rule 4 of C.P.C.
3. I state that I am the permanent resident of Hodavada Village, Madikeri Taluk and I was an agricultural labourer and was earning a monthly income of Rs.10,400/=.

4. I state that on 5.3.2023 at about 7.00 p.m I was returning back home after finishing my work, at around 7.00 p.m when I have reached near my house walking in front of Raffles English Medium School, a Car bearing Registration No. KA 12 P 8178 belonging to the First respondent driven by the second respondent came in a rash and negligent manner in the backside and dashed to me when I was walking on the side of the road and due to the said accident I fell down on the road and sustained grievous injuries on my fore head, right hand, right leg and bleeding injuries all over my body.
5. I state that my father was near the main gate of our house came along with our neighbour Sri. Dinesh were rescue me and took to Napoklu Hospital for first aid in the Car of Sri. Dinesh and the Doctor at Napoklu Hospital advised them to take me to KOIMS (Kodagu Institute of Medical Sciences) Madikeri for further evaluation, examination and better treatment. As per the advice of the doctors in Napoklu Hospital, my father admitted me in KOIMS, Madikeri.
6. I state that I was admitted on 5.3.2023 and treated by Dr. Sathish V.S and Dr. Karunakara G.K and conducted a C.T scan of brain, abdomen, Thorax and pelvis which enabled them to diagnosis me with RTA and frontal bone fracture and orbital anterior wall fracture and discharged on 6.3.2023 and advised my father to take me for further evaluation and better treatment to Mangalore and hence I was taken to Mangalore and admitted in Father Muller Medical Hospital Mangalore as an inpatient on 7.3.2023, undertook treatment and I was discharged on 8.3.2023.
7. I state that the respondent No.1 is the owner of the said Maruti Alto 800 Car bearing registration No. KA 12 P 8278 which is involved in the accident and the accident was caused due to the rash and negligent driving of the

respondent No.2 and the third respondent is the Insurance Company of vehicle of the Respondent No.1 and the Insurance Policy was in currency on the date of the accident and as such the Respondents are jointly and severally liable to pay compensation to me.

8. I state that I have suffered pain, mental agony and shock because of the accident and I have spent huge amount for medical treatment, food, conveyance charge and also for attendant's charge and still I have expected to spend for treatment in future also and inspite of the best medical treatment I am not in a position to do my normal works as I am getting repeated pain while doing my normal works and as such I could not attend the works for so many months.

9. I state that the Napoklu Police registered the FIR vide No.12/2023 against the respondent No.2 and filed charge sheet in C.C.No.742/2023 for the offences Punishable under Section 279 and 338 of I.P.C and the respondent No.2 has admitted his guilt.

10. I state that I have produced the below mentioned documents before this Hon'ble Court for the kind reference of this Hon'ble Court and the said documents may kindly be marked as Exhibits in my favour.

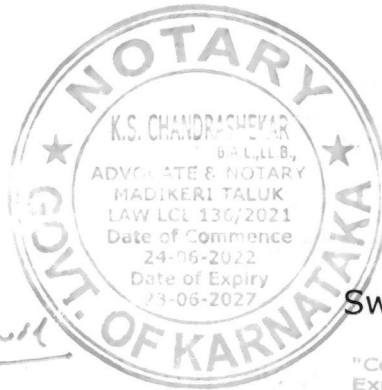
