Charge

I, Hosamani Pundalik, Principal District And Sessions Judge, Kodagu-Madikeri, do hereby charge both of you:

A-1 Jagadeesh B.M.,
S/o Mallappa B.B.
Aged 46 years,
R/at Beluru Basavanahalli,
Somwarpet Taluk,
Kodagu District.

A-2 Ashray,
S/o Manjunath B.M.
Aged 20 years,
R/at Beluru Basavanahalli,
Somwarpet Taluk,
Kodagu District.

A-3 Manjunath B.M.,
S/o Mallappa B.B.
Aged 51 years,
R/at Beluru Basavanahalli,
Somwarpet Taluk,
Kodagu District.

as follows:-

Firstly, that on 31.10.2023 at about 1.30 p.m., in front of the house of Chinnamma of Beluru Basavanahalli, Somwarpet Taluk, Kodagu District, within the jurisdiction of Somwarpet Police Station, all of you in furtherance of your common intention, while C.W1-Nandish was serving food, because of the previous enmity in respect of the property, amongst you, accused No.1 by crashing the beer bottle to the stone had assaulted to C.W1-Nandish on his left stomach, as a result of which CW.1-Nandish sustained injuries and under such circumstance, if by such act, you accused No.1 would caused the death of C.W1-Nandish and would have been guilty of murder and thereby, all of you have committed an offence punishable under section **307** read with section **34** of IPC and within the cognizance of this Court.

Secondly, that on the aforesaid date, time and place, all of you in furtherance of your common intention, abused the complainant in filthy language and thereby gave provocation to C.W1-Nandish intending that such provocation would cause him to break public peace and thereby, all of you have committed an offence punishable under section **504**

read with section **34** of IPC and within the cognizance of this Court.

Lastly, that on the aforesaid date, time and place, all of you in furtherance of your common intention all of you committed criminal intimidation by threatening the CW.1-Nandish for life threat with intent to cause alarm to him and thereby, all of you have committed an offence punishable under section **506** read with section **34 of IPC** and within the cognizance of this Court.

And I hereby direct that all of you be tried by this Court on the above said charges.
