Defendant has acknowledged the receipt of Rs.20,00,000/- (Twenty lakhs) towards the balance sale consideration amount through cheque detailed in the compromise petition and has agreed to execute the registered sale deed within a

year with a liberty to the plaintiff to file execution petition in case of default of the defendant.

It appears that the compromise is voluntary. Accordingly, satisfied and same is accepted.

Parties to bear their own cost. Memo filed by the plaintiff for refund of court fee is accepted.

Office to refund court fee to the plaintiff as per rules on proper identification & acknowledgment.

Office to draw decree in terms of compromise petition. The compromise petition shall form the part of decree.
