Examination-in-chief by Public Prosecutor:

1. PW.1 is my mother, CW.3 is my father, I know CW.4 and 5.

Accused No.3 is my wife. Accused No.1 is my father-in-law.

Accused No.4 is my mother-in-law. Accused No.2 is accused No.1's brother. In the year 2010, I got married with accused No.3.

2. After marriage, I was started to work in Dubai and visit Virajpet once in 2-3 years. I have purchased survey No.65/2, measuring 3 acres of coffee estate situated at Chinivada. I had told accused No.3 that I would sell the property.

Thereafter, accused No.3 has started animosity with me. She left my house alongwith my son to her parents house.

3. I had discussed with CW.5 regarding sale of property, he has agreed to purchase it. I had executed gift deed in favour of my mother. On 25.07.2021 myself, my mother and my father alongwith CW.4 and CW.5 to the property. CW.5 has asked us to show the property as he was intended to purchase it. CW.6 and two other labourers were also taken to the spot to repair the fencing.
4. Around 11.30 am, Accused No.1 to 4 came to my land abused us as lofer boli makle, yenu madata edira namma jagadalli. I told them it is my property, we are repairing the fence. Accused No.1 with katti, with intention to kill her aimed at neck, at that time, my mother raised left hand and sustained deep injury. Accused No.2 with MO.2 assaulted on

my head and caused injury. Accused No.3 with MO.3 assaulted on my head.

5. All the accused threatened us to kill, if entered the property. My mother was shifted to Madikeri District Hospital for treatment. Police came there and recorded statement of my mother. The case was registered against the accused. After sometime, I came to know the accused have also filed counter case against us. After taking bail, visited the police station. The police recorded my statement. The accused are present before the Court and identify them. MO.1 to 3 are the weapons used by the accused. MO.4 to 7 are the cloths of my mother. The exact spot is visible in Ex.P.2 and 3 photographs.

Cross Examination: Sri.CKP Advocate for accused:

6. Accused No.3 was with me till the date of incident. I do not know from 2021, the cases were registered against me. Section 307 of IPC case was registered against me as a

counter case to this case. It is false to suggest that, during subsistence of marriage with accused No.3, I got married another lady for which CC No.552/2024 is pending. OS No.46/2026 is pending. OS No.45/2021 filed by my mother is also pending. The said suit was filed claiming ownership. In Dubai, I was working as a driver cum guest guide. In the year 2013, I had purchased property from accused No.4.

7. I have furnished property documents to police. It is false suggest that, no such documents were furnished. It is false suggest that, accused No.1 out of sale of gold jewels, the property was purchased in my name.

8. We left Virajpet at 10.00-10.15 am and reached the Chinivada at 11.15 am. CW.4 is my Advocate, therefore I had taken him to the spot. I do not know dispute between accused No.1 and CW.5. I do not know there was Civil

dispute between accused No.4 father and CW.5. Before visiting the property, I did not inform to police. We visited the our property first. The accused house is situated at a distance of 100 mts from spot. The accused properties are also situated adjacent to my property.

9. I did not obtain permission from the Civil Court for repair of fencing. Around 45 minutes to one hour quarrel was took place. I have not assaulted the accused. It is true that, the accused have filed counter case in SC No.5003/2022. At the time of incident, I had mobile phone.

10. After incident, I had informed to Ponnampet police station and taken my mother to hospital. Police did not accompany my mother to the hospital. It is false to suggest that, I did not inform the police, myself and my mother have sustained injuries by fall and filed false complaint.

11. I am not appearing in Ex.P.2 and 3 photographs. The survey number board is not visible in Ex.P.2 and 3. Since, I am identifying MO.1 and 2 as such I am identifying the weapons. It is true that, generally the planters use MO.2 and 3 tools. Generally, MO.3 like club is available in the estate.
12. It is false to suggest that, MO.4 to 7 not belongs to my mother and created for the case. It is false to suggest that, the accused have not quarreled with us and not assaulted me and my mother. It is false to suggest that, false case has been filed against the accused to force them to withdraw the case filed against us. It is false to suggest that, MO.1 to 7 are not related to this case and deposing falsely against the accused.
