This case came before Lok-Adalath on this 09th day of December 2023 for final disposal before Smt.G.Deepa B.A.L.L.L.B, Prl. Senior Civil Judge Gokak, Judicial Conciliator and Smt.S.S.Patil Advocate Non-Judicial Conciliator, in the presence of Sri.B.R.Kotagi Advocate for Petitioner, Sri.A.A.Patil Advocate for Respondent No.2 and Respondent No.1 is placed exparte.

It is hereby ordered and awarded in terms of joint memo is as under:-

:: A W A R D ::

The petitioners has filed the above claim petition claiming the compensation towards injuries sustained by petitioner- Shri. Pakrusab S/o Nanesab Nadaf in a road accident occurred on 29.07.2022. In order to indemnity the insured, the petitioner and the Respondent-Insurance company have agreed to settle the claim in full and final settlement for a sum of ₹.2,10,000/- (Rupees Two Lakh Ten Thousand only) and prays this Hon'ble court pass an award accordingly. The respondent No.2 agrees to deposit the said amount within Two months failing which the said amount shall carry an interest at the rate of 6% from the date of decree. The Petitioner is not entitled for any costs.

In the joint memo it is stated that claim of the petitioner is settled in full and final settlement for ₹.2,10,000/- (Rupees Two Lakh Ten Thousand only). On enquiry Conciliators satisfied. In view of the submission of joint memo filed by petitioner and Resp.No.2/ Insurance Company is allowed.
